RULE DISCUSSION

Tab 1 Rule 64B17-4.001, Licensure as a Physical Therapist Assistant by Examination

During the May 2014 board meeting, the board proposed the following draft to clarify the PTA education requirements:

64B17-4.001 Licensure as a Physical Therapist Assistant by Examination.
Every physical therapist who applies for licensure by examination shall file DOH Form #DH-MQA 1142 Application for Licensure, revised 08/14 ~~Revised 08/12~~, which is hereby incorporated by reference and, ~~which~~ is available through http://www.flrules.org/Gateway/reference.asp?No=Ref-____02042 or www.floridaspysicaltherapy.gov/resources ~~www.doh.state.fl.us/mqa~~, and demonstrate to the Board that the applicant:

(1) through (2) No change.

(3) Education,

(a) Has received a degree as a physical therapist assistant from an institution accredited by an appropriate accrediting agency as authorized by Section 486.102, F.S. ~~that, has been approved for the training of physical therapist assistants by the Commission on Accreditation for Physical Therapy Education (CAPTE),~~ at the time of graduation, or

(b) through 2.d. No change.

The text of this rule was published in the Florida Administrative Register on October 13, 2014 and comments from the public were received.

Mr. Harris summarized the history of the 2013 legislative changes and past board discussions.

The board reviewed and discussed the public comments.

A student from St. Petersburg College stated she did thorough research to ensure she graduated from a Commission on Accreditation in Physical Therapy Education (CAPTE) school, so she would be able to sit for the National Physical Therapy Exam (NPTE) and get a job.

The board office received notification that there could possibly be 1200 students in the pipeline that will soon graduate from non-CAPTE programs. This information was shared so that possible preparations can be made to efficiently process these applications.

The board discussed requiring each applicant to appear before the board to be considered.

The board discussed issues with non-CAPTE graduates not being able to sit for the National Physical Therapist Assistant Exam (NPTE) and the Federation of State Boards of Physical Therapy (FSBPT) annual meeting discussion. The Board is comfortable with the FSBPT not allowing access to the NPTE. The board referenced Tab 16 and the upcoming changes proposed by FSBPT.

MOTION: After considering and agreeing with the comments, Dr. Tasso made a motion to reluctantly adopt the rule as originally proposed based on the law implemented by the legislature. The motion was seconded by Dr. Petraglia and carried 3/0.

MOTION: Dr. Petraglia made a motion to ratify the list of physical therapists for licensure by examination/endorsement (Exhibit A), 391 in number starting with PT 29238 and ending with PT 29748. Upon successful completion of the National Physical Therapy Exam and/or the Florida Laws and Rules Exam, shall be licensed. The motion was seconded by Dr. Tasso and carried 3/0.

- Physical Therapist Assistant Applicants

MOTION: Dr. Petraglia made a motion to ratify the list of physical therapists assistants for licensure by examination/endorsement (Exhibit B), 329 in number starting with PTA 24872 and ending with PTA 25257. Upon successful completion of the National Physical Therapy Exam and/or the Florida Laws and Rules Exam, shall be licensed. The motion was seconded by Dr. Tasso and carried 3/0.

Tab 6 Ratification List for Employment Exemption

MOTION: Dr. Petraglia made a motion to ratify the physical therapists, Carl Jones and Kathleen Olive who were granted an employment exemption. The motion was seconded by Dr. Quillen and carried 3/0.

Dr. Musolino addressed the board regarding Tab 1 and possible economic impact. Mr. Harris explained that the board simply is implementing legislation so cost impacts do not have to be quantified.

NEW BUSINESS

Tab 7 Correspondence from U.S. Department of Transportation

The Board of Physical Therapy received a letter from the Federal Motor Carrier Safety Administration requesting a determination as to whether or not the scope of practice for a Florida physical therapist allows him/her to perform a physical examination to medically certify a driver as physically qualified to drive a commercial motor vehicle.

Mr. Harris advised the board to not treat this as a Petition for Declaratory Statement as it is not in the proper format. Mr. Harris also stated submitting a letter to the Federal Motor Carrier Safety Administration is an option, informing them that an opinion cannot be provided due to not being legally sufficient. The letter could also provide the appropriate statutes that would apply.

MOTION: Dr. Petraglia made a motion to decline a response and directed Mr. Harris and Mr. Hall to prepare a written letter. The motion was seconded by Dr. Tasso and carried 3/0.

Tab 8 Renewal Application Questions

During the August 2014 meeting, the Board inquired as to what questions are asked of licensees during the renewal process. A questionnaire was provided to confirm what is required of licensees during the renewal process.

The Board's intention is to notify licensees of the requirement to report criminal pleas and convictions within thirty days as required by Section 456.072(1)(x).

Since the renewal form is a standard department form and cannot be revised specifically for one board, staff suggested placing a message on the online services homepage so that when licensees log on to renew their license this information will be displayed. The Board requested this be completed.

Dr. Tasso wished to share with the Board the new and improved Florida Board of Physical Therapy website. Screenshots from the website were provided for review.

Dr. Tasso would like to see updates sent out when new rules become effective.

Tab 10 Board Chairs/Vice-Chairs Annual Meeting

The Annual Board Chairs/Vice-Chairs meeting was in Tallahassee on September 10, 2014. Highlights from the meeting were provided for the Board's review.

Mr. Hall summarized the Division's annual financial reports.

Dr. Petraglia questioned the lower cash balance for 2014-2014 year. Mr. Hall will research and report at the next meeting.

Tab 12 Coursework Tool Changes

In March, the Board of Directors passed a motion to modify the Interpretive Guidelines for the Federation of State Boards of Physical Therapy (FSBPT) Coursework Tool (CWT) to eliminate the distinction between General Education and Professional Education. The CWT is accepted by all member boards to evaluate whether a foreign education PT or PTA's education is substantially equivalent to a US PT or PTA education. The change was implemented November 1, 2014.

This was placed on the agenda for informative purposes.

OLD BUSINESS

Tab 13 Pro Bono Services

During the August 2014 meeting, the Board discussed the possibility of allowing continuing education credit for the performance of pro bono services. The board reviewed examples of rules of other healthcare boards. The program is available to certain practitioners who volunteer their services in the public school system. Information

from the Departments website was provided to confirm the requirements and procedures.

After the discussion the Board decided to move forward revising the rule to allow licensees to receive continuing education credit for pro bono services.

The Board agreed the rule will need to specify the following requirements in order to obtain credits. The requirements will be:

- No more than six (6) CE credits can be earned.
- For everyone two (2) volunteer hours, one contact hour of CE earned.
- Licensees must apply in writing and include all requirements listed in the Rule.

Mr. Hall will inquire with other board offices regarding their experiences and processes.

On August 8, 2014 Mr. Repass appeared before the board due to his criminal and discipline history of another healthcare license. Mr. Repass' application was denied due to the disciplinary actions taken on his license for being terminated from a treatment program for impaired practitioners and for violating any law or rule of Section 486 and 456, Florida Statutes.

Mr. Repass submitted a request for a review of the Notice of Intent to Deny Application for Licensure.

MOTION: After discussion Dr. Tasso, made a motion to deny the request for reconsideration. The motion was seconded by Dr. Quillen and carried 3/0.

PETITION FOR DECLARATORY STATEMENT

Ms. Ybanez was not present nor represented by legal counsel. She has filed a petition seeking a declaratory statement for Section 486.081, F.S. She is asking the Board to provide a Declaratory Statement the lists all the accepted lawfully authorized examining boards based in the European Union, and/or, a Declaratory Statement that lists all of the accepted lawfully authorized physical therapy examinations offered in the European Union that can be considered by the Board pursuant to Section 486.081, F.S.

MOTION: After discussion, Dr. Quillen made a motion to deny the Petition for Declaratory Statement of Section 486.021, F.S due to the petitioner not being a substantially effected person and the petition not being legally sufficient. The motion was seconded by Dr. Tasso and carried 3/0.

PETITION FOR VARIANCE OR WAIVER OF RULE

Ms. Samuel was present and sworn in by the court reporter.

On August 8, 2014 Ms. Samuel came before the board to file a Petition for Waiver of Rule 64B17-3.003, F.A.C. Based on her education she did not meet the required content hours including specific courses. Her petition was denied without prejudice and her application was tabled for one of the next two meetings while her educational deficiencies were corrected.

Ms. Samuel has submitted a new FCCPT evaluation confirming her professional education deficiencies were corrected. She has also submitted medical documentation to support an undue hardship.

Ms. Samuel has filed a new petition for waiver of Rule 64B17-3.003. She requested a waiver from the education requirement(s) in regards to deficiencies on her FCCPT evaluation in her general education. Based on her date of graduation, she does not meet the required content hours including specific courses.

MOTION: After discussion, Dr. Tasso made a motion to grant the Petition for Variance or Waiver of Rule 64B17-3.003 based on principles of fairness and documented undue hardship. The motion was seconded by Dr. Petraglia and carried 2/1. Dr. Quillen opposed.

MOTION: After discussion, Dr. Tasso made a motion to approve Ms. Samuel's application for licensure and to certify her to sit for the Florida Laws and Rules Exam. Upon a passing score on the exams shall be licensed. The motion was seconded by Dr. Petraglia and carried 2/1. Dr. Quillen opposed.

PERSONAL APPEARANCE PURSUANT TO §456.013(3)(c), F.S.

Tab 8 Carlos Cevallos, PT by Examination

Mr. Cevallos submitted a request to withdraw his application.

Tab 9 Jigar Vyas, PT by Endorsement

Mr. Vyas was present and sworn in by the court reporter.

He was required to appear by the Chair in regards to his "yes" answer in the disciplinary section of his application.

MOTION: After discussion, Dr. Petraglia made a motion to approve Mr. Vyas's application for licensure and to certify him to sit for the Florida Laws and Rules Exam and upon a passing score on the exams shall be licensed. The motion was seconded by Dr. Tasso and carried 3/0.

Tab 10 Harichandra Vennelakanti, PT by Endorsement

Mr. Vennelakanti was present and sworn in by the court reporter.

He was required to appear by the Chair in regards to his "yes" answer in the disciplinary section of his application.

Mr. Vennelakanti was sanctioned by the Federation of State Boards of Physical Therapy (FSPBT) for participating in the improper posting of multiple National Physical Therapy Exam (NPTE) items. His Indiana license was disciplined due to violation of the Indiana

state codes. Also Mr. Vennelakanti's Michigan license was disciplined due to lack of good moral character and evidence of fraud or deceit in obtaining or renewing a license or registration.

MOTION: After discussion, Dr. Petraglia made a motion to deny Mr. Vennelakanti's application for licensure due to having a license adversely acted upon in another jurisdiction, violating Sections 456.072(1)(b)(f)(dd) F.S., 486.125(1)(g)(k) F.S., and Rule 64B17-3.006. The motion was seconded by Dr. Quillen and carried 3/0.

Tab 11 Jasin Knights, PT Endorsement

Mr. Knights was not present nor sworn in by the court reporter.

MOTION: Dr. Petraglia made a motion to require Mr. Knights' appearance at the February meeting. The motion was seconded by Dr. Tasso and carried 3/0.

Tab 12 Vladislav Khlopine, PT by Endorsement

Mr. Khlopine was present and sworn in by the court reporter.

He was asked to appear to discuss his criminal history.

MOTION: After discussion, Dr. Petraglia made a motion to approve Mr. Khlopine's application for licensure and to certify him to sit for the Florida Laws and Rules Exam and upon a passing score on the exams shall be licensed. The motion was seconded by Dr. Tasso and carried 3/0.

Tab 13 Mohamed Hassen, PT by Endorsement

Mr. Hassen was present and sworn in by the court reporter.

He was required to appear in regards to his education issues.

According to Mr. Hassen's credential evaluation from FCCPT, he meets the number of general education required but he lacks the required course in Physical Sciences, One course in Physics with Lab.

Mr. Hassan provided proof of practice hours and a record of education information provided to FCCPT for New York licensure. This information was reviewed and included in the Florida FCCPT evaluation.

MOTION: Dr. Tasso made a motion to approve Ms. Hassen's application for licensure and to certify him to sit for the Florida Laws and Rules Exam, and upon a passing score on the exam shall be licensed contingent upon proof of completion of the education deficiencies. Proof must be received by January 31, 2015 otherwise the applicant must come back before the board at the February 13, 2015 meeting. The motion was seconded by Dr. Petraglia and carried 3/0.

The board questioned his ability to work as a researcher with the Miami Project to Cure Paralysis and his role as a researcher. Mr. Hassan clarified that this is a part of his Ph.D program requirements.

Mr. Harris read into the record the potential exemption outlined in Section 486.161.

Tab 14 Megan McFarland, PT by Examination

Ms. McFarland was present and sworn in by the court reporter.

She was asked to appear to discuss her criminal history. Dr. Quillen stated on the record that he personally knows this applicant but is able to make a fair and impartial decision.

Board members inquired about her completion of certain court ordered requirements as these were not provided as part of her application materials. Ms. McFarland stated she would be able to obtain proof of completion of these documents electronically before the end of the meeting.

The Board agreed to a short recess to allow Ms. McFarland to retrieve her documents.

The Board reconvened and reviewed the newly provided documents.

MOTION: After discussion, Dr. Petraglia made a motion to approve Ms. McFarland's application for licensure and to certify her to sit for the Florida Laws and Rules Exam and the National Physical Therapy Exam and upon a passing score on the exams shall be licensed. The motion was seconded by Dr. Tasso and carried 3/0.

Tab 15 Cristin Barnes, PTA by Examination

Ms. Barnes was present and sworn in by the court reporter.

She was asked to appear to discuss her criminal history.

The board discussed the issue about being unable to pay restitution to the Victims Impact Trust Fund. Mr. Harris provided information to Ms. Barnes about how to submit payment and will ensure the appropriate contact information is provided.

The board wants to see Ms. Barnes make good faith effort to complete her restitution.

He was asked to appear to discuss his criminal history.

MOTION: After discussion, Dr. Petraglia made a motion to approve Mr. Perez's application for licensure and to certify him to sit for the Florida Laws and Rules Exam and the National Physical Therapy Exam and upon a passing score on the exams shall be licensed.
