**RULE DISCUSSION**

**Tab 1 Anti-Trust Presentation**

Ed Tellechea, Office of the Attorney General, presented an Overview, Implications, and the New Regulatory Landscape in response to a US Supreme Court ruling.

**Tab 2 64B17-6.005 Costs of Duplicating Medical Records**

As a part of the Department's rules reduction project, during the August 6, 2015 meeting it was voted to repeal Rule 64B17-6.0044 and 64B17-6.005, in order to combine and streamline the rule to 64B17-6.0042.

In consideration of the comments received by the Joint Administrative Procedures Committee (JAPC), this was placed on the agenda for reconsideration of the decision to repeal Rule 64B17-6.005.

**64B17-6.005 Costs of Duplicating Medical Records.**

(1) Any person licensed pursuant to Chapter 486, Florida Statutes, required to

furnish release copies of reports or patient medical records, or make reports or records available for digital scanning may condition such release upon payment, but by the requesting party shall charge no more than of the actual cost of copying, including reasonable staff time reasonable costs of reproducing the records.

~~(2) Reasonable costs of reproducing copies of written or typed documents or reports shall not be more than the following:~~

~~(a) For the first 25 pages, the cost shall be \$1.00 per page.~~

~~(b) For each page in excess of 25 pages, the cost shall be \$.25 per page.~~

~~(3) Reasonable costs of reproducing x-rays and such other kinds of records shall be the actual costs. "Actual costs" means the cost of the material and supplies used to duplicate the record and the labor and overhead costs associated with the duplication.~~

**MOTION:** Dr. Petraglia made a motion to approve the proposed language and vacate the decision to repeal Rule 64B17-6.005 and directed counsel to proceed with rule making. The motion was seconded by Ms. Christina Pettie and carried 5/0.

**MOTION:** Dr. Petraglia made a motion to find the proposed revisions will not be likely to directly or indirectly increase regulatory costs to any entity (including government) in excess of \$200,000 in the aggregate in Florida within 1 year after the implementation of the rule. The Motion was seconded by Dr. Tasso and carried 5/0.

**Tab 3 Initial Application Update**

Due to recent Rule changes, the initial application required several updates. Board staff completed updates to each rule reference that was either in the repeal or the revision process.

Also board staff updated each website link to the correct updated web link. New to the application is an Email Notification request. With this verbiage applicants may request all correspondence be received via email. This will eliminate board staff from the requirement of mailing the initial deficiency letter.

The board analyzed and considered the impact of the rule change.

#### **Tab 10 Licensure Compact**

The Federation of State Boards of Physical Therapy has launched a project to develop an interstate licensure compact for physical therapy. The purpose of the compact is to increase consumer access to physical therapy services by reducing regulatory barriers to interstate mobility and cross- state practice. Mark Lane, Vice President of the FSBPT

attended the meeting alongside Tom Caldwell and Nancy Kirsch and provided a brief explanation of the licensure compact project.

Dr. Tasso and Nancy Kirsch spoke of the Jurisprudence Assessment Module (JAM) The JAM is an online and on-demand learning and assessment tool.

Mr. Harris was requested to look into the statutory authority for JAM. The licensure compact will require legislative action.

**Tab 11 Laws and Rules Examination Updates**

During the November meeting, the Board requested information regarding how The Federation of State Boards of Physical Therapy (FSBPT) monitors rule changes that will affect the Florida laws and rules exam.

The board office has been in communication with Jeff Rosa, Continuing Competency Managing Director for FSBPT, regarding how these changes are monitored. Mr. Rosa explained that the FSBPT subscribes to a notification service that tracks legislative bills and rule changes through the Florida Administrative Register. The FSBPT receives alerts twice weekly to track any changes. If a change impacts an examination questions, the question is modified and a revised form of the exam is sent to Prometric to be uploaded into their exam delivery system.

In addition to the notification service, advance notice of potential changes provided by Board staff also allows the FSBPT to prepare potential modifications in advance of the effective dates of the change. This helps speed the length of time needed to make the required changes.

Mr. Repass submitted a new application on January 5, 2015 for the board's consideration. He has paid the full amount of fines and costs to the Board of Massage.

Mr. Repass was denied by the Physical Therapy Board on February 13, 2015 due to having another license acted against. Mr. Repass requested a Hearing Not Involving Disputed Facts at the May 1, 2015 board meeting. The Board entered into a Final Order denying his application.
