RULE DISCUSSION

1. Legislative Update

Mr. Hall provided an overview of legislative changes during the 2016 legislative session that could impact the Board/Council operations. This was for information purposes only.

2. CS/CS/HB 941-Department of Health

During the 2016 legislative session CS/CS/HB 941 was signed and will impact the operations of the board office. The key provisions that were changed are as followed:

456.013(7) – Medical errors CE no longer required at initial licensure. Medical errors CE will only be required at renewal.

These rules will need to be amended to remove the medical errors requirement.

- 3.001 – Physical therapist licensure by examination application
- 3.003 – Physical therapist licensure by endorsement application

- 4.001 – Physical therapist assistant licensure by examination application
- 4.003 – Physical therapist assistant licensure by endorsement application

456.024 – Multiple changes related to expedited licensure for Members of the United States Armed Forces and their spouses.

No rule changes are required to implement this provision.

456.0361 – Electronic continuing education tracking system. Department may not renew a license until a licensee complies with all applicable CE requirements.

No rule changes are required to implement this provision.

456.057 – Allows the Department to contract with a third party to be the custodian of medical records in the event of the death of a practitioner, the mental or physical incapacitation of a practitioner or the abandonment of medical records by a practitioner.

No rule changes are required to implement this provision.

456.0635 – Applicants with a 456.0635 conviction (certain drug and fraud convictions) will no longer have an exemption when they were enrolled in an educational training program on or before July 1, 2009.

The application must be amended to delete the reference to this exemption.

486.102 – Restores language that was in effect prior to legislative change in 2013. A CAPTE accredited physical therapist assistant program is now required.

- Rule 64B17-4.001(3)(a) will need to be updated to specify that a CPTA accredited program is required.

486.109 – Prior reference to a random audit is removed which allows the physical therapy profession to take part in CE@Renewal. Licenses will not be renewed unless CE requirements are met.

No rule changes are required to implement this provision.

MOTION: Dr. Tasso made a motion to open Rules 64B17-3.001, 3.001, 4.001, and 4.003 for development and adopt the changes to the application that will be implemented on July 1, 2016. The motion was seconded by Dr. Petraglia and carried 4/0.

MOTION: Dr. Petraglia made a motion to find the proposed revisions do not have an adverse impact on small businesses and will not be likely to directly or indirectly increase regulatory costs to any entity (including government) in excess of \$200,000 in the aggregate in Florida within 1 year after the implementation of the rule. The motion was seconded by Dr. Tasso and carried 4/0.

MOTION: Dr. Tasso made a motion to approve the application oath language in the applicant statement as provided by Board Council. The motion was seconded by Mr. Chenoweth and carried 4/0.

MOTION: Dr. Petraglia made a motion to find the proposed revisions do not have an adverse impact on small businesses and will not be likely to directly or indirectly increase regulatory costs to any entity (including government) in excess of \$200,000 in the aggregate in Florida within 1 year after the implementation of the rule. The motion was seconded by Dr. Tasso and carried 4/0.

MOTION: Dr. Petraglia made a motion to restore the language in Rule 64B17-4.001(3)(a) to be in compliant with 486.102 Florida Statute and to correct the language to state Physical Therapist Assistant. The motion was seconded by Dr. Tasso and carried 4/0.

MOTION: Dr. Petraglia made a motion to find the proposed revisions do not have an adverse impact on small businesses and will not be likely to directly or indirectly increase regulatory costs to any entity (including government) in excess of \$200,000 in the aggregate in Florida within 1 year after the implementation of the rule. The motion was seconded by Dr. Tasso and carried 4/0.

Eduardo Rodriguez from the Professional Hands Institute approached the Board regarding the status of his current students and the new legislative law that will take effect on July 1, 2016.

Tad Fisher, President of the Florida Physical Therapy Association addressed the board.

MOTION FOR HEARING NOT INVOLVING DISPUTED ISSUES OF MATERIAL FACT

1. **Janice Marie Binkley, PTA 16485
(Case No. 2015-08556)
(PCP-Tasso, Hughes, Bumgarner)**

Respondent was present and sworn in by the court reporter.

Dr. Tasso was recused due to participation in the Probable Cause Panel.

Ms. Gilani summarized the case for the Board. Respondent was charged with the following violation: Section 486.125(1)(k), and 456.072(1)(w) Florida Statutes (2002), by failing to Report to the Board within 30 days after the licensee has been convicted or found guilty of, or entered a plea of nolo contendere to, regardless of adjudication, a crime in any jurisdiction constitutes grounds for discipline.

MOTION: Dr. Petraglia made a motion to find that the Respondent was properly served and has requested an informal hearing. The motion was seconded by Mr. Chenoweth and carried 3/0.

Dr. Petraglia recused due to participation in the Probable Cause Panel.

Ms. Gilani summarized the case for the Board. Respondent was charged with the following violation: Section 486.125(1)(k), Florida Statutes (2014), through a violation of Section 456.072(1)(hh), Florida Statutes by being terminated from a treatment program for impaired practitioners for failure to comply, without good cause, with terms of the monitoring or treatment contract entered into by the licensee.

MOTION: Mr. Chenoweth made a motion to find that the Respondent was properly served and waive the right to a proper hearing. The motion was seconded by Dr. Pabian and carried 3/0.

MOTION: Dr. Pabian made a motion to adopt the materials under Tab 4 and any addendum materials into evidence in this proceeding. The motion was seconded by Dr. Tasso and carried 3/0.

MOTION: Dr. Pabian made a motion to adopt the findings of fact as set forth in the Administrative Complaint. The motion was seconded by Dr. Tasso and carried 3/0.

MOTION: Dr. Pabian made a motion to adopt the conclusions of law as set forth in the Administrative Complaint and find that this constitutes a violation of the Chapters 486 and 456, Florida Statutes. The motion was seconded by Dr. Tasso and carried 3/0.

MOTION: After discussion Dr. Pabian made a motion revoke Mr. Jahns' license due to lengthy endeavors by board staff to notify the Respondent. The motion was seconded by Dr. Tasso and carried 3/0.

Ms. Gilani summarized the case for the Board. Respondent was charged with the following violation: Section 486.123 Florida Statutes (2015) by being arrested for charge of sexual battery of a minor under twelve years of age.

MOTION: Dr. Tasso made a motion to accept Voluntary Relinquishment. The motion was seconded by Dr. Petraglia and carried 4/0.

PETITION TO LIFT RESTRICTION

6. August Garcia, PTA 21151 (Case No. 2014-04985) (No PCP)

Respondent was present and sworn in by the court reporter.

Dr. Kay Tasso recused due to participation in Probable Cause Panel.

An Administrative Complaint (AC) was filed on October 14, 2014 against Mr. Garcia for violating Section 486.125(1)(e), Florida Statutes (2013), by failing to maintain acceptable standards of physical therapy. On March 5, 2015 a Final Order was filed imposing the following penalties:

- Reprimand
- \$2,000.00 fine to be paid within two (2) years of the filing of the Final Order
- Completion of two (2) Board approved courses specifically aimed at behavioral treatment methods to be completed within one (1) year of the filing of the Final Order. The courses shall be submitted to Ms. Pettie for approval.
- Direct supervision for one (1) year to include quarterly reports from the supervising physical therapist to affirm the care and quality is appropriate.
- Restrict pediatric practice for one (1) year. Mr. Garcia must appear before the board after one (1) year and petition the Board to lift restriction.

Mr. Garcia is requesting his restrictions to be lifted.

MOTION: Mr. Chenoweth made a motion to grant the Petition to Lift Restrictions. The motion was seconded by Dr. Petraglia and carried 3/0.

PETITION FOR EXTENSION REQUEST TO PAY FINES AND COSTS

8. Thomas R. Inman

Mr. Inman was not present nor represented by counsel.

An Administrative Complaint (AC) was filed on April 15, 2014 against Mr. Inman for violating Section 486.125(1)(k), Florida Statutes (2010-2013), through a violation of Section 456.072(1)(x), Florida Statutes (2010-2013), by failure to report a crime in any jurisdiction. On March 5, 2015 a Final Order was filed imposing the following terms:

- Reprimand
- \$1,000.00 fine to be paid within one (1) year of the filing of the Final Order.
- Costs of \$202.22 to be paid within one (1) year of the filing of the Final Order.
- Completion of the Laws and Rules Exam to be completed within six (6) months of the filing of the Final Order.

Mr. Inman completed the Laws and Rules Exam on August 31, 2015. He requested a six month extension to pay fines and costs.

MOTION: After discussion, Dr. Tasso made a motion to deny the Request for Extension. The motion was seconded by Dr. Petraglia and carried 4/0.
