

## Remedial Information

If and when a PT or PTA licensure candidate fails the NPTE for the third time, Florida Statute 486.051, the law, requires completion of a remedial course before you are allowed to test a fourth time. It is in your best interest to request an Examination Performance Feedback Report from the FSBPT (Federation of State Boards of Physical Therapy). This shows you your knowledge deficits or if you have other test taking problems. We are providing a known list of companies that provide subject matter review and/or test taking strategies. Based on your previous test results, it is you that will need to decide which is best for you.
