**RULE DISCUSSION**

**Tab 1 64B17-5.001 Requirements for Reactivation of an Inactive or Retired License**

Board staff conducted an analysis of Chapter 486 to ensure all requirements are being implemented. The review noted a discrepancy between the reactivation requirements in Section 486.085, F.S. and Rule 64B17-5.001, F.A.C.

Board Counsel drafted a rewrite of the rule to incorporate these provisions.

**64B17-5.001 Requirements for Reactivation of an Inactive or Retired License.**

An inactive or retired license shall be reactivated upon receipt by the Board office of the following:

- (1) Payment of all applicable fees, including
  - (a) the biennial renewal fee as specified by Rule 64B17-2.005(1);
  - (b) the unlicensed activity fee as specified by Rule 64B17-2.001(5);
  - (c) the reactivation fee as specified by Rule 64B17-2.005(6);

(d) the change of status fee as specified by Rule 64B17-2.001(7);

(2) Documentation of compliance with all continuing education requirements as provided in Rule 64B17-9.001, F.A.C., including prevention of medical errors, for the biennium during which the licensee last held an active license; and

(3)(a) Documentation of completion of ten (10) hours of continuing education for each year the license was inactive, including two (2) hours on the prevention of medical errors. No more than six (6) hours of continuing education may be completed by home study per year of inactive status. In addition, the applicant must document completion of two (2) hours of continuing education specifically in Florida Physical Therapy Laws and Rules within the twelve (12) months immediately preceding application for reactivation;

(b) Documentation that the applicant is licensed and in good standing in another state and has actively engaged in the practice of physical therapy for the four (4) years immediately preceding application for reactivation. For purposes of this paragraph, "actively engaged in the practice of physical therapy" means the applicant practiced at least four hundred (400) hours per year in a state where they maintained licensure; or

(c) Documentation of application for and successful passage of the National Physical Therapy Examination, including payment of all associated fees.

**MOTION:** Dr. Petraglia made a motion to approve the proposed language as amended above and directed counsel to open the rule for development. The motion was seconded by Dr. Tasso and carried 5/0.

The board analyzed and considered the impact of the rule change.

**MOTION:** Dr. Tasso made a motion to find the proposed revisions do not have an adverse impact on small businesses and to find the proposed revisions will not be likely to directly or indirectly increase regulatory costs to any entity (including government) in excess of \$200,000 in the aggregate in Florida within 1 year after the implementation of the rule. The motion was seconded by Mr. Chenoweth and carried 5/0.

## **Tab 2 64B17-7.0027 Procedure for Compliance with Board Ordered Laws and Rules Exam**

During a review of the rules, board staff determined that the appropriate application form was not incorporated into 64B17-7.0027, F.A.C. This application form is used by licensees who are board ordered to take the laws and rules exam or who wish to receive continuing education.

Revisions were made to the application form to include the email address disclosure and update the website address in the instructions.

### **64B17-7.0027 Procedure for Compliance with Board Ordered Laws and Rules Exam.**

Licensees ordered to take and pass the Florida Laws and Rules Examination as a result of a disciplinary proceeding or reinstatement, must file DOH Form #DH-MQA 1144, Application Materials For the PT Florida Laws and Rules Examination Application, Revised 05/15, which is available through <http://www.flrules.org/Gateway/reference.asp?No=Ref-03444> or [www.floridasphysicaltherapy.gov/resources](http://www.floridasphysicaltherapy.gov/resources) ~~www.doh.state.fl.us/mqa~~.

(f) Licensees who file DOH form #DH-MQA 1144, "Application Materials For The Florida Laws and Rules Examination, (Revised ~~05/15 08/13~~)", incorporated by reference, which is available through [www.floridasphysicaltherapy.gov/resources](http://www.floridasphysicaltherapy.gov/resources) ~~www.doh.state.fl.us/mqa~~ or at <http://www.flrules.org/Gateway/reference.asp?No=Ref-03444>, and take and pass the Florida laws and rules examination shall receive two (2) hours of continuing education per biennium. The continuing education credit shall be awarded only for the biennium in which the examination was taken and passed. Continuing education credit shall not be awarded to licensees that take and pass the examination as a result of a disciplinary proceeding or as a board ordered condition of initial licensure, re-activation or reinstatement.

**MOTION:** Dr. Petraglia made a motion to approve the proposed language as amended above and open Rules 64B17-7.0027 and 9.001 for development. The motion was seconded by Dr. Tasso and carried 5/0.

The motion was seconded by Mr. Chenoweth and carried 5/0.

## Tab 3 64B17-7.003 Reinstatement of Suspended and Restricted License

During a review of the rules, board staff determined the need to propose a more streamlined process for individuals requesting reinstatement of their license after their license has been suspended or restricted.

Board counsel proposed a rewrite of 64B17-7.003. F.A.C., so that the rule may be more clear and streamlined.

## 64B17-7.003 Reinstatement of Suspended and Restricted Licenses.

(1) When the Board has suspended or otherwise restricted the license of a Physical Therapist or Physical Therapist Assistant, the licensee may petition the Board for reinstatement or removal of restrictions. The Board shall reinstate a suspended license, or remove restrictions, upon its finding that the licensee has complied with all terms and conditions of the final order and the licensee possesses the present ability to safely

practice physical therapy.

(2) Where a license has been suspended or otherwise restricted for a specific period of time, and the licensee is seeking reinstatement or removal of restrictions prior to completion of the specified period, the Petition shall contain sufficient facts to allow the Board to find:

(a) The licensee has complied with all terms and conditions of the final order, excluding completion of the specified time period;

(b) The licensee possesses the present ability to safely practice physical therapy;  
and

(c) Continuation of suspension or restriction of the license presents an undue hardship on the licensee and is not necessary for the continued protection of the public health, safety and welfare.

(3) In order to demonstrate the present ability to safely practice physical therapy, a licensee shall submit evidence which may include, as applicable:

(a) Completion of all continuing education courses approved by the Board required by the final order;

(b) Submission of evaluations of mental and/or physical examinations by appropriate professionals which attest to the licensee's present ability to safely engage in practice, or conditions under which safe practice can be attained.

(c) Compliance with prescribed treatment within a program designed to alleviate alcohol, drug, or other chemical dependencies, including necessary aftercare measures or a plan for continuation of such treatment as appropriate.

(d) If action was taken against the license based on conviction or being found guilty of, or entry of a plea of nolo contendere to, a crime, proof that all criminal sanctions imposed by the court have been satisfied.

(e) If discipline was imposed against a Florida license based on action taken against the license or authority to practice by the licensing authority of another jurisdiction, proof that the licensee has satisfied all terms and conditions imposed by that licensing authority.

(f) The licensee's employment history, personal and professional references, or other factors not enumerated, which demonstrate the licensee's rehabilitation and present ability to safely engage in the practice of physical therapy.

(4) All petitions for reinstatement or removal of restrictions must contain sufficient facts to allow the Board to determine the licensee's compliance with the final order and present ability to safely practice. The licensee must submit all documentation supporting the petition prior to the Board meeting at which the Board will consider the petition.

(5) If the Board reinstates the license of the petitioner, it may order reasonable conditions of probation or participation in the Professional Resources Network (PRN), as those conditions are related to the violations that resulted in the final order imposing discipline. In determining whether to impose conditions or PRN participation, the Board will consider how long the licensee has been out of practice, whether and to what extent practice problems led to the disciplinary action, and whether mental, physical, or substance abuse problems led to the disciplinary action.

**MOTION:** Dr. Tasso made a motion to approve the proposed language as amended above and directed counsel to open the rule for development and proceed with rule making procedures. The motion was seconded by Ms. Pettie and carried 5/0.

The board analyzed and considered the impact of the rule change.

**MOTION:** Dr. Petraglia made a motion to find the proposed revisions do not have an

adverse impact on small businesses and to find the proposed revisions will not be likely to directly or indirectly increase regulatory costs to any entity (including government) in excess of \$200,000 in the aggregate in Florida within 1 year after the implementation of the rule. The motion was seconded by Dr. Tasso and carried 5/0.

#### **Tab 4 64B17-9.001 Continuing Education**

The application form used by licensees to complete the laws and rules exam who are board ordered to take the exam or who wish to receive continuing education is incorporated into both applicable rules, 64B17-7.0027 and 9.001. So that appropriate changes can be made to 64B17-7.0027, 9.001 must also be revised to incorporate the revised application form.

Revisions were made to the application form to include the email address disclosure and update the website address in the instructions.

Action on this rule was taken in Tab 2 above.

#### **Tab 5 64B17-9.002 Performance of Pro Bono Services**

During the August 2014 board meeting, the board discussed the possibility of allowing continuing education credit for the performance of pro bono services.

At the February 2015 board meeting, the board requested additional language be added to define areas of critical care.

Board Counsel proposed the draft language for the Board's review.

#### **64B17-9.002 Performance of Pro Bono Services.**

(1) As provided in Section 456.013(9), F.S., up to two (2) hours per biennium of continuing education credit may be fulfilled by the performance of physical therapy pro bono services to the indigent or to underserved populations or in areas of critical need within the state where the licensee practices.

(a) For purposes of this rule, the term "indigent" is as defined in section 154.304(9), F.S.

(b) For purposes of this rule, "underserved populations" are areas so designated by the Secretary of the Department of Health and Human Services pursuant to Title 42 United States Code section 254(3)(b).

(c) For purposes of this rule, "areas of critical need" are areas so determined by the State Surgeon General pursuant to section 458.315(3), F.S.

(2) In order to receive credit under this rule, licensees must make written application to the Board and receive approval in advance. One (1) hour of continuing education credit shall be given for each two (2) hours worked. If the licensee intends to provide services in underserved or critical need areas, the application shall provide a brief explanation as to those facts.

**MOTION:** Mr. Chenoweth made a motion to approve the proposed language as amended and directed counsel to open the rule for development and proceed with rule making procedures. The motion was seconded by Dr. Petraglia and carried 5/0.

The board analyzed and considered the impact of the rule change.

**MOTION:** Dr. Tasso made a motion to find the proposed revisions do not have an adverse impact on small businesses and to find the proposed revisions will not be likely to directly or indirectly increase regulatory costs to any entity (including government) in excess of \$200,000 in the aggregate in Florida within 1 year after the implementation of the rule. The motion was seconded by Mr. Chenoweth and carried 5/0.

In accordance with Section 7 of Executive Order 11-72 “No later than July 1, 2011, and on July 1 of each successive year, each agency under the direction of the Governor shall submit to the Office of Fiscal Accountability and Regulatory Reform (OFARR), an Annual Regulatory Plan (ARP) that shall identify and describe each rule that the agency expects to begin promulgating during the next twelve-month period.”

Prior to the board/council meeting, the Board reviewed the rules and were prepared to note any rules they would like to be added to the 2015-2016 plan.

For your reference, Chapter 64B17, Florida Administrative Code and the Executive Order 11-72 were included.

In general, the plan should include any rules the board/council plans to amend during the upcoming year and any rules currently under development that may still be in process as of July 1. Staff recommended that all application rules be added to the plan as changes to the application are often needed and cannot always be anticipated.

If a rule was not included and a subsequent need to change the rule arises, the board/council is not prohibited from making needed changes, conversely simply placing a rule on the plan does not require rule development be undertaken.

Board Counsel drafted a proposed ARP (Exhibit C) for the Board to consider. The Board requested that all rules currently going through the process be added.

## **REQUEST FOR MODIFICATION OF FINAL ORDER**

### **Tab 3 Gregory Idell, PT 20008 Case No. 2007-04763**

Respondent was present and sworn in by the court reporter. Mr Idell was represented by Jon Pellett, Esq. Dr. Zeigler, representative from Professional Resource Network, was present to provide the board with the status of Mr. Idell's progress.

Mr. Idell first appeared before the Board on September 14, 2007. Ms. Quimby-Pennock, Prosecuting Attorney, presented the case as a Settlement Agreement. The Board accepted the following terms of the Settlement Agreement:

- Participation in the Professionals Resource Network (PRN) program.
- Fine of \$3,000.00 to be paid within 180 days of the filing of the Final Order.
- Costs of \$1,500.00 to be paid within 180 days of the filing of the Final Order.
- Registration for the Florida laws and rules exam within 60 days of the filing of the Final Order. Successful passage of laws and rules exam within 1 year of the filing of the Final Order.
- Probation for no less than five (5) years with the following terms;
  - Respondent must work in setting where other physical therapists are engaged in practice
  - Must not work in home health setting
  - Tolling provisions
  - Must appear before board during last three (3) months of probation

Mr. Idell signed a Voluntary Agreement to Withdraw from Practice effective June 2006 as a physical therapist in the state of Florida.

Mr. Idell appeared before the Board on November 6, 2009 after undergoing an evaluation through Professionals Resource Network (PRN) and PRN cleared him to return to practice. Mr. Idell requested reinstatement of his license, and removal of the Voluntary Withdrawal from Practice and an extension of the administrative fees that was imposed to be due no later than eighteen (18) months from the date he is reinstated.

The Board reinstated Mr. Idell's license with the following stipulations:

- License shall be placed on probation for five (5) years and licensee shall comply with all terms outlined in signed Settlement Agreement.
- If employer is a licensed Physical Therapist, employer is to submit quarterly reports to include documentation, billing practices and proof of competency and professionalism regarding patient care. If employer is not a licensed Physical Therapist, a monitor approved by the Board Chair must submit the quarterly reports.
- An extension of twelve (12) months to pay the fine and costs from the date of reinstatement.

Mr. Idell is currently requesting the Board modify the requirement of participation in the Professionals Resource Network set forth in his original settlement agreement.

**MOTION:** Dr. Tasso made a motion to deny the Modification of Final Order due to not finding substantial change in circumstances. The motion was seconded by Dr. Petraglia and carried 3/2. Mr. Chenoweth and Ms. Pettie opposed.

#### **HEARING NOT INVOLVING DISPUTED ISSUES OF MATERIAL FACT**

##### **Tab 4 James Repass, PTA by Examination**

Mr. Repass was present and sworn in by the court reporter.

Mr. Repass was denied by the Physical Therapy Board on August 8, 2014 due to having another license acted against.

Mr. Repass appeared before the Board on November 7, 2014 to request reconsideration. The board denied his request.

Mr. Repass submitted a new application on January 5, 2015 for the board's consideration. He has paid the full amount of fines and costs to the Board of Massage.

His application was denied by the Physical Therapy Board on February 13, 2015 due to having another license acted against.

Mr. Repass has petitioned the denial of his application.

**MOTION:** Dr. Petraglia made a motion to find that the Respondent was properly served and has requested an informal hearing. The motion was seconded by Ms. Pettie and carried 5/0.

**MOTION:** Dr. Petraglia made a motion to adopt the findings of fact as set forth in the Notice to Deny Application for Licensure. The motion was seconded by Ms. Pettie and carried 5/0.

**MOTION:** Dr. Petraglia made a motion to issue a Final Order denying Mr. Repass' application for licensure. The motion was seconded by Dr. Tasso and carried 5/0.

## **REVIEW OF PETITION FOR ADMINISTRATIVE HEARING INVOLVING DISPUTED ISSUES OF FACT**

### **Tab 5 Warren Weber, PT by Endorsement**

Mr. Weber was present and was sworn in by the court reporter. Mr. Weber was represented by Allen Grossman, Esq.

On May 2, 2014, the Board approved his licensure application with the following conditions to be completed with six months (due on November 17, 2014):

- Obtain medical malpractice insurance
- Obtain an approved supervising physical therapist
- Successful completion of the Florida laws and rules exam
- Within one year, he must complete two approved live courses on prevention of malpractice continuing education within one year.
- Mr. Weber is placed on one year direct supervision by an approved monitor.

Mr. Weber requested modification of his conditions at the August 8, 2014 meeting and was denied.

Mr. Weber successfully completed the Florida laws and rules exam on May 12, 2014. He also completed a five hour course related to medical malpractice on October 18, 2014, which was approved by the Board's vice chair.

On February 13, 2015 Mr. Weber's application was denied due to failure to comply with the remaining terms of his Notice of Intent issued on May 16, 2014.

Mr. Weber petitioned the Board for an Administrative Hearing, which was deferred to the Board for consideration.

**MOTION:** Mr. Chenoweth made a motion to vacate the previous Notice of Intent and approve the application for licensure without conditions. The motion was seconded by Ms. Pettie. The motion failed with a 2/3 vote. Dr. Pabian, Dr. Tasso, and Dr. Petraglia opposed.

**MOTION:** Dr. Petraglia made a motion to vacate the previous Notice of Intent and to grant licensure with conditions to include:

- Completion of a four hour continuing education course on modalities to be completed within one year from date of licensure.
- General supervision for one year with quarterly reports from a licensed physical therapist supervisor indicating timely and appropriate documentation, communication, and patient skills. The one year period shall begin once the Florida license is issued.

The motion was seconded by Ms. Pettie and carried 5/0.

## **PERSONAL APPEARANCE PURSUANT TO §456.013(3)(c), F.S.**

### **Tab 6 Maureen Nash, PT by Endorsement**

Ms. Nash was present and sworn in by the court reporter. Ms. Nash was represented by Allen Grossman, Esq.

She was asked to appear to discuss her criminal, personal, and discipline history.

Ms. Nash appeared before the Board at the February 13, 2015 meeting. After discussion, Ms. Nash withdrew her application. She submitted a new application for the Board's consideration.

**MOTION:** After discussion, Dr. Tasso made a motion to approve the application for licensure and authorize Ms. Nash to sit for the Florida Laws and Rules Exam. Upon successful completion of a PRN evaluation and compliance with their recommendation, licensure is granted. Applicant has 30 days to contact PRN, 60 days to schedule an evaluation and 90 days to comply or licensure is denied. Board staff is delegated to approve licensure once all terms are completed. The motion was seconded by Ms. Pettie and carried 5/0.

### **Tab 7 Michael Horan, PTA by Examination**

Mr. Horan was present and sworn in by the court reporter.

He was asked to appear to discuss his criminal, personal, and discipline history.

On October 28, 2010, an Administrative Complaint was filed charging Mr. Horan with three counts of violating Section 456.072(1)(x), F.S. for failing to report a conviction or plea to the board within 30 days.

In February 2011, the Board entered into a Settlement Agreement that included the following:

- Board appearance
- Letter of Concern
- \$1000.00 fine to be paid within one year (completed 3/9/2012)
- Costs of \$1,441.56 to be paid within one year (completed 3/9/2012)
- Successful completion of the laws and rules exam (completed 3/12/2012)

On February 18, 2014, an Administrative Complaint was filed charging Mr. Horan with a violation of Section 456.072(1)(x), F.S. for failing to report a conviction or plea to the board within 30 days.

In August 2014, the Board entered into a Final Order revoking Mr. Horan's license.

Mr. Horan submitted a new application for consideration.

**MOTION:** After discussion, Dr. Tasso made a motion to approve the application for licensure and authorize Mr. Horan to sit for the Florida Laws and Rules Exam. Upon

successful completion of a PRN evaluation and compliance with their recommendation, licensure is granted. Applicant has 30 days to contact PRN, 60 days to schedule an evaluation and 90 days to comply or licensure is denied. Board staff is delegated to approve licensure once all terms are completed. The motion was seconded by Ms. Pettie and carried 4/1. Dr. Petraglia was opposed.

**Tab 8 Hemal Bhagat, PT by Endorsement**

Mr. Bhagat was not present nor represented by counsel.

His appearance was required per the Chair, with concern to the discrepancies in his education.

According to Mr. Bhagat's credential evaluation from FCCPT, he does not meet the requirements of Florida as he lacks required course content. In general education he is lacking Biological Sciences. In professional education he is lacking Clinical Science – Cardiopulmonary System Evaluation and Related Professional Coursework – Professional Behavior, Research and Clinical Decision Making, Legal and Ethical Aspects of PT Practice.

He would like to be considered for licensure in Florida pursuant to Rule 64B17-3.003, F.A.C. Michigan provided another record of his education information completed by ICD, confirming his education met their requirements for licensure in 2007. He provided proof of practice hours. Board staff confirmed that prior to September 1, 2009, Michigan did not use the Federation of State Boards of Physical Therapy (FSBPT) Coursework Tool, which is a requirement per Rule 64B17-3.003(2)(a).

**MOTION:** After discussion, Dr. Tasso made a motion to deny his application due to not meeting the requirements in Rule 64B17-3.003, however the denial is suspended to allow the applicant ten (10) days to withdraw his application. The motion was seconded by Dr. Petraglia and carried 5/0.

**Tab 9 Joseph Bartoletti, PT by Endorsement**

Mr. Bartoletti was present and sworn in by the court reporter.

He was asked to appear to discuss his criminal and personal history.

Dr. Zeigler addressed the board with information on the Minnesota monitoring program.

Mr. Bartoletti waived the ninety (90) day application requirement to table his application. He will contact PRN for an evaluation to determine if a contract will be necessary.

Mr. Bartoletti's application will be placed on the agenda for the next scheduled meeting. A personal appearance will not be required.

**Tab 10 Vinod David, PT by Endorsement**

Mr. David was present and sworn in by the court reporter.

He was asked to appear to discuss his criminal history.



Mr. Vinod David applied for licensure on March 26, 2014 and was initially approved on January 16, 2015. On March 6, 2015, he notified the board office of a recent criminal charge. Based on receiving this information, his exam approval was withdrawn as his application required a board appearance.

Board staff informed the Board that Mr. David submitted his original credential evaluation which was performed on the Michigan checklist form. As discussed in a previous tab, all evaluations must be completed on the appropriate Federation of State Boards of Physical Therapy Coursework Tool.

After discussion Mr. David withdrew his application.

If Mr. David submits a new application to Florida, his criminal charge can be administratively cleared by staff.

#### **Tab 11 Duval Russell, PTA by Examination**

Mr. Russell was present and sworn in by the court reporter.

He was asked to appear to discuss his personal history.

**MOTION:** After discussion, Dr. Tasso made a motion to approve Mr. Russell's application for licensure and to certify him to sit for the Florida Laws and Rules Exam and the National Physical Therapy Exam and upon a passing score on the exams shall be licensed. The motion was seconded by Dr. Pabian and carried 5/0.

#### **Tab 19 Sherry Williams, PT by Endorsement**

Ms. Williams was present and sworn in by the court reporter.

She was asked to appear to discuss her examination issues.

Ms. Williams was initially license in Virginia in 1968. Due to the creation of the Board of Physical Therapy with Virginia in 2000 a subsequent separation from the Board of Medicine, many licensure records were lost.

Ms. Williams was unable to provide a score transfer of her exam scores due to the loss of records in Virginia.

Ms. Williams was able to obtain a license in New York and Maryland per the reciprocity process.

**MOTION:** After discussion, Dr. Petraglia made a motion to approve Ms. Williams' application for licensure and to certify her to sit for the Florida Laws and Rules Exam and upon a passing score on the exams shall be licensed. The motion was seconded by Dr. Pabian and carried 5/0.

#### **Tab 20 Michelle Vann, PTA by Examination with Temporary Permit**

Ms. Vann was present and sworn in by the court reporter.

She was asked to appear to discuss her criminal history.

**MOTION:** After discussion, Dr. Tasso made a motion to approve Ms. Vann's application for licensure and to certify her to sit for the Florida Laws and Rules Exam and the National Physical Therapy Exam and upon a passing score on the exams shall be licensed. The motion was seconded by Dr. Petraglia and carried 5/0.
