#### **RULE DISCUSSION AND/OR DEVELOPMENT**

1. 64B17-2.001, F.A.C., Fees for Application, Re-Application and Initial Licensure.

Board Counsel proposes changes to Rule 64B17-2.001, F.A.C., to clarify that only incomplete applications expire after one year pursuant to 456.013(1), F.S.

#### 64B17-2.001 Fees.

- (1) Each applicant for licensure shall pay a nonrefundablean application fee payable to the Department of Health. An incomplete application shall expire 1 year after initial filing. Upon expiration of an incomplete application, an applicant must submit a new application and fee to be considered for licensure. The application fee is nonrefundable and is valid for one year from the original submission of the application. After one year from the date of original submission of an application and fee, an applicant must submit a new application and fee to be considered for licensure.
  - (2) The application fee for licensure by taking the national examination or endorsement is \$100.
- (3) When the Board certifies the applicant to sit for the examination, it is the applicant's responsibility to complete the examination process with the national vendor. Pursuant to the Americans with Disabilities Act, any applicant requesting special accommodations shall comply with Department of Health Rule 64B-1.005, F.A.C. (effective 11/5/14), which is incorporated by reference herein and may be obtained from the

- (4) The initial licensure fee is \$75.
- (5) The biennial renewal fee for an active license is \$75.
- (6) The biennial renewal fee for an inactive license is \$50.
- (7) The retired status fee is \$50.
- (8) The delinquency fee is \$55.
- (9) The fee for reactivation is \$50.
- (10) The change of status fee is \$40.
- (11) The duplicate license fee is \$25.
- (12) The certification of a public record fee is \$25. Duplicating fees as specified in Section 119.07(4), F.S., shall also apply.
- (13) An applicant who fails to pass the national examination and/or the laws and rules examination must meet the requirements of subsections (2) and (3) as applicable.

**MOTION:** After discussion, Mr. Chenoweth voted to accept the changes the language. The motion was seconded by Dr. Pabian and carried 2/2. Dr. Petraglia and Dr. Tasso opposed. Motion failed.

The Board advised Board Staff to interpret the Rule based on statute and advised Board staff to no longer close complete application files due to no statutory authority.

The Board opened the Rule up for consideration.

**MOTION:** After discussion, Mr. Chenoweth voted to accept the changes the language. The motion was seconded by Dr. Pabian and carried 4/0.

**MOTION**: Mr. Chenoweth made a motion to find the proposed revisions will not be likely to directly or indirectly increase regulatory costs to any entity (including government) in excess of \$200,000 in the aggregate in Florida within 1 year after the implementation of the rule. The Motion was seconded by Dr. Petraglia and carried 4/0.

## 2. RULE 64B17-3.002 Licensure Examination and Passing Score; Laws and Rules Examination; Additional Requirements After Third Failure (New Title).

Board Counsel proposes changes to the last sentence in 64B17-3.002(1) to clarify that the existing requirement that "applicants for licensure by examination must have obtained a passing score on the NPTE examination within five (5) years immediately prior to the filing of the application" does not apply to all applicants, but rather only to applicants who have previously taken the exam.

#### And

Board Counsel proposes clarification of (4)(a) to more clearly state that when an applicant has failed the exam and wishes to retake the exam, that person must apply to retake the exam (clarifying that this is not a reapplication for licensure).

#### Proposed changes for subsection (1):

- (1) The licensure examination for physical therapists shall be the National Physical Therapy Examination (NPTE) for Physical Therapists developed by the Federation of State Boards of Physical Therapy (FSBPT). The licensure examination for physical therapist assistants shall be the
- National Physical Therapy Examination for Physical Therapist Assistants developed by the FSBPT. An applicant for licensure by examination who has previously taken the NPTE examination must have obtained a passing score on the NPTE examination within the five (5) years immediately prior to the filing of the application for licensure.
  - (4) Examination retakes.
- (a) In order to retake either the NPTE or the Florida Laws and Rules Examination, an applicant must reapply to retake the exam, using DOH Form #DH-MQA 1143, Re-Exam Application, Revised 11/15, incorporated by reference, which is available through http://www.flrules.org/Gateway/reference.asp? No= or www.floridasphysicaltherapy.gov/resources.

Full rule language as previously approved by the Board:

## <u>64B17-3.002</u> Licensure Examination Subjects and Passing Score; <u>Laws and Rules Examination</u>; Additional Requirements After Third Failure; <u>Laws and Rules Examination</u>.

- (1) The licensure examination <u>for physical therapists</u> shall be the National Physical Therapy Examination (NPTE) for Physical Therapists developed by the Federation of State Boards of Physical Therapy (FSBPT). The licensure examination for physical therapist assistants shall be the National Physical Therapy Examination for Physical Therapist Assistants developed by the FSBPT. An applicant for licensure by examination must have obtained a passing score on the NPTE examination within the five (5) years immediately prior to the filing of the application.
- (2) Applicants must obtain a passing score on the National Physical Therapy Examination for Physical Therapists developed by the Federation of State Boards of Physical Therapy.
- (3) An applicant must reapply, using DOH Form #DH MQA 1143, Re Exam Application, Revised 08/09, incorporated by reference, which is available through www.doh.state.fl.us/mqa, in order to retake the examination. If an applicant wishes to take the examination for the fourth time, the applicant must submit to the Board for approval satisfactory evidence of having successfully completed the following since the last taking of the examination: successful completion of a course of study or internship designed to prepare the applicant for the physical therapy examination. An applicant who has completed these additional requirements may take the examination on two more occasions.
  - (2) Florida Laws and Rules Examination.
- (a)(4) All applicants for licensure including those <u>seeking licensure without examination licensed</u> (by endorsement) <u>under Rule 64B17-3.003, F.A.C.</u>, are required to take and pass the <u>Florida</u> Laws and Rules Examination developed by the <u>FSBPT</u> <u>Federation of State Boards of Physical Therapy</u>. Passing scores on the Laws and Rules Examination are <u>set by the FSBPT and are not no longer</u> valid <u>for if</u>-more than five years after <u>have passed since</u> the Applicant took the examination.
- (b)(a) The Florida Laws and Rules Examination has 40 scored questions and the content and approximate weights are:
  - 1. through 5. No change
- 6. Consumer Advocacy 12.5%. In order to achieve a passing score on the examination, an applicant must obtain a score equal to or greater than the scaled score based upon a passing score study conducted by the Federation of State Boards of Physical Therapy.
- (b) Applicants must reapply to retake the Laws and Rules Examination, using DOH Form #DH MQA 1143, Re Exam Application, Revised 08/09, which is available through <a href="https://www.doh.state.fl.us/mqa">www.doh.state.fl.us/mqa</a>.
  - (3) Passing Scores.
- (a) Passing scores on the NPTE and Florida Laws and Rules Examination are determined by the FSBPT. In determining whether an applicant has received a passing score, the Board will use the information contained in the applicant's FSBPT Score Report.

- (b) In cases where an applicant's Score Report does not state "pass" or "fail," the Board will deem an applicant to have passed the examination if the applicant's raw scaled score is not less than one point five (1.5) standard deviations below the national average for that examination offering.
  - (4) Examination retakes.
- (a) In order to retake either the NPTE or the Florida Laws and Rules Examination, an applicant must reapply, using DOH Form #DH-MQA 1143, Re-Exam Application, Revised 11/15, incorporated by reference, which is available through http://www.flrules.org/Gateway/reference.asp? No= or www.floridasphysicaltherapy.gov/resources.

**MOTION:** After discussion, Dr. Petraglia voted to accept the changes the language. The motion was seconded by Dr. Tasso and carried 4/0.

**MOTION**: Dr. Tasso made a motion to find the proposed revisions will not be likely to directly or indirectly increase regulatory costs to any entity (including government) in excess of \$200,000 in the aggregate in Florida within 1 year after the implementation of the rule. The Motion was seconded by Dr. Petraglia and carried 4/0.

#### 3. 64B17-7.001, F.A.C., Disciplinary Guidelines.

Section 456.072, F.S., Grounds for Discipline; Penalties; Enforcement – has been amended with the addition of subsection (oo).

(oo) Willfully failing to comply with s. 627.64194 or s. 641.513 with such frequency as to indicate a general business practice.

This will require amendment of each profession's disciplinary guideline rule.

#### 64B17-7.001 Disciplinary Guidelines.

(1) When the Board finds that an applicant or licensee whom it regulates has violated the below-listed provisions, it shall issue a final order imposing appropriate penalties, for each count, as set forth in Section 456.072(2), F.S., within the ranges recommended in the following disciplinary guidelines. As part of a final order imposing appropriate penalties, the board shall consider requiring an applicant or licensee to attend board meetings, perform community service, take described continuing education courses, or take and pass the applicable jurisprudence examination. The identification of offenses are descriptive only; the full language of each statutory provision cited must be considered in order to determine the conduct included. For all persons subject to this rule, probation may include specific compliance conditions and conditions of probation may be required following any period of suspension of license. For applicants, all offenses listed herein are sufficient for refusal to certify an application for licensure. If the Board makes a finding of

pecuniary benefit or self-gain related to the violation, then the Board shall require refund of fees billed and collected from the patient or a third party on behalf of the patient. In addition to any other discipline imposed, the Board shall assess the actual costs related to the investigation and prosecution of a case. In addition to or in lieu of any guideline penalties provided herein, if the violation is for fraud or making a false or fraudulent representation, the Board shall impose a fine of \$10,000 per count or offense.

(hh) Section 456.072(1)(00), F.S.: Willfully failing to comply with s. 627.64194 or s. 641.513 with such frequency as to indicate a general business practice – from a minimum of a reprimand and a \$1,000 fine, up to a maximum fine of \$10,000 and/or revocation of license. After the first offense, from a minimum of two years of probation and a fine of \$2,500 up to a maximum fine of \$10,000 and/or revocation.

**MOTION:** After discussion, Dr. Tasso voted to accept the proposed language. The motion was seconded by Mr. Chenoweth and carried 4/0.

**MOTION**: Dr. Petraglia made a motion to find the proposed revisions will not be likely to directly or indirectly increase regulatory costs to any entity (including government) in excess of \$200,000 in the aggregate in Florida within 1 year after the implementation of the rule. The Motion was seconded by Mr. Chenoweth and carried 4/0.

#### 7. Ratification List for Approved Applicants

Physical Therapist Applicants

**MOTION:** Dr. Petraglia made a motion to ratify the list of physical therapists for licensure by examination/endorsement (Exhibit A), 450 in number starting with PT 31215 and ending with PT 31994. Upon successful completion of the National Physical Therapy Exam and/or the Florida Laws and Rules Exam, shall be licensed. The motion was seconded by Dr. Tasso and carried 4/0.

Physical Therapist Assistant Applicants

**MOTION:** Dr. Petraglia made a motion to ratify the list of physical therapists assistants for licensure by examination/endorsement (Exhibit B), 343 in number starting with PTA 26421 and ending with PTA 27055. Upon successful completion of the National Physical Therapy Exam and/or the Florida Laws and Rules Exam, shall be licensed. The motion was seconded by Dr. Tasso and carried 4/0.

#### 8. Ratification List for Employment Exemption.

**MOTION:** Dr. Petraglia made a motion to ratify the list of physical therapists/assistants who administratively approved exemptions, 1 in number, Lisa Michelle Innis, PTA 19331. The motion was seconded by Dr. Tasso and carried 4/0.

#### **NEW BUISNESS**

#### 9. Revised Delegation of Authority

At the August 2016 meeting Board staff was requested to add delegations related to the appointment of Probable Cause Panel members.

A revised delegation is provided for Board review and comment. The Board is requested approve or suggest amendments if needed In addition to formatting and minor editing the following substantive changes are noted:

- (1) Two new delegations related to Probable Cause Panel selection were added
- (2) The delegation related to the Authority to require a PRN Evaluation was corrected to Full Board rather than a committee and the unused category of "Delegate Authority to Committee" was deleted

**MOTION:** After discussion Dr. Petraglia voted to accept the proposed delegation. The motion was seconded by Dr. Tasso and carried 4/0.

#### 10. 2016 Board Chairs, Healthiest Weight and Budget Liaison Meetings

The Boards Chairs/Vice-Chairs, Healthiest Weight and Budget Liaison meetings were held on September 27-28 in Tallahassee.

Attendees were invited to highlight or discuss any topics they wish.

Dr. Tasso provided highlights of the Healthiest Weight Liaison meeting.

#### 11. USCIS Intent to deny FCCPT's Authorization

The Foreign Credentialing Commission on Physical Therapy (FCCPT) is one of two agencies authorized by the federal government to issue healthcare worker certificates to those who have graduated from a non- CAPTE accredited program overseas and who are seeking employment in this country via an H1B visa.

The authority granted by the United States Citizenship and Immigration Services (USCIS) to FCCPT to perform evaluations for the purpose of granting healthcare worker certifications is at risk.

During the September 12, 2016 webinar conducted by the FSBPT, it was confirmed that credential evaluations for the purpose of licensure will not be impacted due to the loss of accreditation. Rule 64B17-3.001, F.A.C., specifies the criteria for credentialing agencies and the loss of FCCPTs ability to grant healthcare worker certifications will not impact board operations.

#### 12. FSBPT Updates

#### Steve Chenoweth

Mr. Chenoweth has reached out to the FSBPT and requested they provide the Board with any current or future changes to be implemented. Mr. Chenoweth will provide a brief overview of the discussion.

Mr. Chenoweth spoke with Mark Lane and Susan Layton. He inquired if Board staff would benefit from the Alternate Pathway.

#### • NPTE Eligibility Changes

During the February 12, 2015 meeting the Board discussed changes to the National Physical Therapy Exam (NPTE) eligibility requirements and how these changes would be implemented. The Board has no statutory authority to require these changes and the nature of some of the requirements make a legislative fix unlikely.

- Low score limit Candidates who receive two (2) very low scores in the exam will not be allowed to test again. A very low score is defined as performing at or close to chance level (scaled scores 400 and below). Effective January 1, 2016. No Florida applicants have yet been impacted.
- Lifetime limit Candidates will be able to take the exam a maximum
  of six (6) times. An individual can take the NPTE for a physical
  therapist six times and also take the NPTE for a physical therapist
  assistant six times if he or she is otherwise qualified to do so.
  Effective January 1, 2016.
- The two remaining eligibility requirements, English language proficiency (TOEFL) and determination of substantial equivalence using the FSBPT coursework tool for all non-CAPTE graduates, including non-CAPTE PTA graduates. Effective January 1, 2017.

#### Coursework Tool 6

FSBPT's Coursework Tool for Foreign Educated Physical Therapists (CWT) is used by credentialing agencies to compare foreign educated PT coursework with CAPTE-accredited PT program coursework in order to determine substantial equivalence.

When the Commission on Accreditation in Physical Therapy Education (CAPTE) updates its PT or PTA educational standards, FSBPT develops a new CWT. Each version of the CWT is developed, standardized, validated and overseen by FSBPT.

Provided to the Board was an overview of the new CWT 6. This CWT will take effect January 1, 2017.

#### 13. Annual Financial Reports

#### **OLD BUISNESS**

#### 14. Licensure Compact

The purpose of the FSBPT Licensure Compact is to facilitate interstate practice of physical therapy with the goal of improving public access to physical therapy services. The practice of physical therapy occurs in the state where the patient/client is located at the time of the patient/client encounter. The Compact preserves the regulatory authority of states to protect public health and safety through the current system of state licensure. The Compact can only be adopted through legislative change.

The Board discussed the Licensure Compact at the August 4, 2016 meeting and determined further investigation into the Compact would be needed. Provided for review was the Licensure Compact Language, Milestones, Current Status of the Compact, and Florida DOH Questions and Answers.

Jamie Dyson from the FPTA addressed the Board and confirmed FPTA's interest in pursuing the licensure compact.

Dr. Petraglia and Dr. Tasso discussed the downsides to the licensure compact.

After full discussion, the Board stated that they are in favor of the Compact.

#### 15. Anti-Trust

During the August 4, 2016 meeting, the Board requested additional discussion regarding antitrust due to the possibility of Federal legislation addressing the issue.

The board office has received notification from the Federation of State Boards of Physical Therapy (FSBPT) that a State Licensing Board Antitrust Act has been drafted to add state licensing boards to The Local Government Antitrust Act (LDAA) of 1984. The draft language was provided for review.

Dr. Tasso inquired if the legislative language was moving forward.

Ms. Norr provided an overview of the process and status of the language.

#### 16. CAPTE Accreditation Legislation

The Chair, in response to a request, approved a discussion to consider recent legislation that amended 456.102, F.S., reinstating the Commission on Accreditation in Physical Therapy Education (CAPTE) accreditation requirement for physical therapist assistants. Concerns have been raised about students enrolled in non-CAPTE programs that did not graduate prior to the effective date of the legislation.

A subsequent letter to the Governor, addressing this issue, was provided for review.

Dr. Petraglia stated she understands and appreciates the concerns addressed by Senator Garcia, she reiterated the Board has no statutory authority to address Senator Garcia's concerns. Dr. Petraglia confirmed that the Board has no authority to grant loan forgiveness.

Dr. Petraglia stated that the Board has been lenient and fair to these students and the Board has made effort to accommodate these students in the situation presented.

#### 17. Oath Requirement

In August, the Board directed proposed legislation to be submitted to the Department for consideration in any Departmental legislative package. After submission, the assessment was that the legislative change is not needed and the case JSL v. Levy 994 So 2d 394 (2008) was provided to support the determination. Therefore, the legislative changes will not be moving forward with the Department.

Suggested changes to form DH-MQA 1142, Applicant Statement, to include new "oath" language for the fourth paragraph:

Under penalties of perjury, I declare that I have read the foregoing document, and the evidence presented herein for the purpose of demonstrating, to the satisfaction of the board, that I possess the qualifications preliminary to examination required by sections 486.041 and 486.103, or that I possess licensure in another state, the District of Columbia, or a territory as required by section 486.107, Florida Statutes, is true

The following Chapter 486 statutes require an oath:

**486.041 Physical therapist; application for license; fee.**—A person who desires to be licensed as a physical therapist shall apply to the department in writing on a form furnished by the department. She or he shall embody in that application evidence under oath, satisfactory to the board, of possession of the qualifications preliminary to examination required by s. 486.031. The applicant shall pay to the department at the time of filing the application a fee not to exceed \$100, as fixed by the board. *History.*—s. 4, ch. 57-67; s. 2, ch. 73-354; s. 4, ch. 78-278; s. 2, ch. 79-116; ss. 2, 3, ch. 81-318; ss. 6, 24, ch. 83-86; ss. 5, 17, 18, ch. 86-31; s. 31, ch. 88-205; s. 4, ch. 91-429; s. 459, ch. 97-103; s. 178, ch. 97-264; s. 158, ch. 99-397.

**486.103 Physical therapist assistant; application for license; fee.**—A person who desires to be licensed as a physical therapist assistant shall apply to the department in writing on a form furnished by the department. She or he shall embody in that application evidence under oath, satisfactory to the board, of possession of the qualifications preliminary to examination required by s. 486.104. The applicant shall pay to the department at the time of filing the application a fee not to exceed \$100, as fixed by the board.

## 486.107 Physical therapist assistant; issuance of license without examination to person licensed in another jurisdiction; fee.—

- (1) The board may cause a license to be issued through the department without examination to any applicant who presents evidence to the board, under oath, of licensure in another state, the District of Columbia, or a territory, if the standards for registering as a physical therapist assistant or licensing of a physical therapist assistant, as the case may be, in such other state are determined by the board to be as high as those of this state, as established by rules adopted pursuant to this chapter. Any person who holds a license pursuant to this section may use the words "physical therapist assistant," or the letters "P.T.A.," in connection with her or his name to denote licensure hereunder.
- (2) At the time of making application for licensing without examination pursuant to the terms of this section, the applicant shall pay to the department a fee not to exceed \$175 as fixed by the board, no part of which will be returned.
