#### **RULE DISCUSSION AND/OR DEVELOPMENT**

#### 1. 64B17-6.001, F.A.C., Minimum Standards of Physical Therapy Practice

Board Counsel proposed the following rule amendment for the Board to consider:

#### 64B17-6.001 Minimum Standards of Physical Therapy Practice.

- (1) Definitions For purposes of this rule only, the words and phrases listed below are defined in the following manner:
  - (a) (e) No change
- (f) General supervision Supervision of a physical therapist assistant, other than by direct supervision, whereby the physical therapist is accessible at all times by two-way communication, available, to respond to an inquiry when made, and readily available for consultation during the delivery of care, and is within the same geographic location as the physical therapist assistant.
  - (g) (i) No change
  - (2) No change
  - (3) Physical Therapist Responsibilities. Physical therapists shall:
  - (a) (f) No change
  - (g) When participating in student and/or trainee programs, ensure that the academic

programs are accredited or in candidacy by the appropriate accrediting agency recognized by statute, and that the physical therapist provides on-site supervision when students are performing patient care activities. When participating in student and/or trainee programs, assure that the programs are approved or pending approval by the appropriate accrediting agency recognized by statute.

- (h) No change
- (4) Physical Therapist Assistant Responsibilities. Physical therapist assistants shall:
- (a) (f) No change
- (g) When participating in student and/or trainee programs, ensure that the academic programs are accredited or in candidacy by the appropriate accrediting agency recognized by statute, and that the physical therapist assistant provides on-site supervision when students are performing patient care activities. When participating in student and/or trainee programs, assure that the programs are approved or pending approval by the appropriate accrediting agency recognized by statute.
  - (5) (7) No change

#### **Licensure of Physical Therapist Assistants**

The rules in Rule Chapter 64B17-4 have been incorporated into the re-write of Rule Chapter 64B17-3. Upon the adoption of Chapter 3, Chapter 4 will need to be repealed.

#### CHAPTER 64B17-4 LICENSURE OF PHYSICAL THERAPIST ASSISTANTS

64B17-4.001 Licensure as a Physical Therapist Assistant by Examination (Repealed)

64B17-4.002 Licensure Examination Subjects and Passing Score; Additional Requirements After

Third Failure; Laws and Rules Examination (Repealed)

64B17-4.003 Licensure by Endorsement (Repealed)

64B17-4.006 Examination Security and Sanctions for Subversions (Repealed)

#### 64B17-4.001 Licensure as a Physical Therapist Assistant by Examination.

Every physical therapist assistant who applies for licensure by examination shall file DOH Form #DH-MQA 1142 Application for Licensure, revised 08/14, which is hereby incorporated by reference, and is available through http://www.flrules.org/Gateway/reference.asp?No=Ref-04796 or www.floridasphysicaltherapy.gov/resources, and demonstrate to the Board that the applicant: (1) Is eighteen years old.

- (2)Possesses a good moral character.
- (3) Education,

(a) Has received a degree as a physical therapist assistant from an institution accredited by an appropriate accrediting agency as authorized by Section 486.102, F.S., at the time of graduation,

- (b) Has graduated from a school giving a course for physical therapist assistants in a foreign country; and
- 1. Has received a determination that the credentials are equivalent to education required for licensure as a physical therapist assistant in the United States. Educational credentials equivalency
- shall be determined by the Foreign Credentialing Committee on Physical Therapy (FCCPT) or any other Board approved credentialing agency that meets at least the following criteria: a.Has a comprehensive, standardized orientation and training program for all reviewers who must be experienced and knowledgeable in the area of physical therapist assistant education. b. Has an audit and quality assurance or review committee that regularly meets to monitor the evaluation process and to provide random audits of the credentials reviews.
- c.Uses the Federation of State Boards of Physical Therapy (FSBPT) coursework evaluation tool, that reflects the educational criteria in place at the time of graduation.
- d.Employs full time staff support including an international expert in fundamental studies, applied science, and technical education credential equivalency and analysis.
- e.Has an updated, current, and comprehensive resource document library available for reference.
- f.Uses two independent physical therapists or physical therapist assistants to perform the professional education component of the credentials reviews.
- g.Uses original documentation from the institution with institutional seals and signatures and does not permit notarized copies of transcripts or course descriptions for credentials reviews.

  2.The report from the board approved credentialing agency, in which the educational expert, physical therapist, or physical therapist assistant evaluator is not affiliated with the institutions or individuals under review, interpreting the foreign credentials in terms of educational equivalency in the United States, shall, at a minimum, contain the following information:
- a.A clear and definitive statement as to whether the education is equivalent to a CAPTE accredited physical therapist assistant educational program.
- b.Whether the institution is accredited by any governmental agency, and if so, which agency. c. A list of courses in fundamental studies, applied science, and technical education.
- d. All opinions contained in the report shall be substantiated by reference to the source materials which form the basis for the opinion.

### 64B17-4.002 Licensure Examination Subjects and Passing Score; Additional Requirements After Third Failure; Laws and Rules Examination.

(1)The licensure examination shall be the National Physical Therapy Examination (NPTE) for Physical Therapist Assistants developed by the Federation of State Boards of Physical Therapy. An applicant for licensure by examination must have obtained a passing score on the NPTE examination within the five (5) years immediately prior to the filling of the application.

(2)In order to achieve a passing score on the examination, an applicant must obtain a score equal to or greater than the scaled score recommended by the Federation of State Boards of Physical Therapy.

(3)An applicant must reapply, using DOH Form #DH-MQA 1143, Re-Exam Application, Revised 08/09, which is available through www.doh.state.fl.us/mqa, in order to retake the examination. If an applicant wishes to take the examination for the fourth time, the applicant must submit to the Board for approval satisfactory evidence of having successfully completed the following since the last taking of the examination: successful completion of a course of study or internship designed to prepare the applicant for the physical therapy assistant examination. An applicant who has completed these additional requirements may take the examination on two more occasions.

(4)All applicants for licensure including those licensed by endorsement under Rule 64B17-4.003, F.A.C., are required to take and pass the Laws and Rules Examination developed by the Federation of State Boards of Physical Therapy. Passing scores on the Laws and Rules

Examination are no longer valid if more than five years have passed since the Applicant took the examination.

(a)The Laws and Rules Examination has 40 scored questions and the content and approximate weights are:

- 1. Legislative Intent and Definitions 25%;
- 2. Board Powers and Duties 5%;
- 3. Licensure and Examination 7.5%:
- 4. Patient Care 35%;
- 5.Disciplinary Action and Unlawful Practice 15%; and

6.Consumer Advocacy 12.5%. In order to achieve a passing score on the examination, an applicant must obtain a score equal to or greater than the scaled score based upon a passing score study conducted by the Federation of State Boards of Physical Therapy. (b)Applicants must reapply to retake the Laws and Rules Examination, using DOH Form #DH-MQA 1143, Re-Exam Application, Revised 08/09, which is available through www.doh.state.fl.us/mga.

#### 64B17-4.003 Licensure by Endorsement.

(1)An applicant, filing DOH Form #DH-MQA 1142 Application for Licensure, revised 08/14, which is hereby incorporated by reference, and is available through http://www.flrules.org/Gateway/reference.asp?No=Ref-04797 or

www.floridasphysicaltherapy.gov/resources, and demonstrating that he or she is licensed inanother state may be licensed to practice as a physical therapist assistant by endorsement by presenting evidence of active licensure in another jurisdiction, under oath, and evidence satisfactory to the Board that the applicant from such other jurisdiction has been licensed under standards for licensure as high as those maintained in Florida. The standard for determining whether those requirements are as high as those in Florida shall be whether the applicant was required to meet educational standards equivalent to those set forth in subsection 64B17–4.001(3), F.A.C., and whether the written examination taken for licensure in such other jurisdiction was through the designated national physical therapist assistants examination provider certified by the Department. An applicant who has failed to pass the National Physical Therapy Examination for Physical Therapist Assistants by or on the fifth attempt, regardless of the jurisdiction through which the examination was taken, is precluded from licensure.

(2)An applicant who has been educated in a foreign country may demonstrate minimum qualifications by providing the following:

(a)A certified copy of the credential evaluation used by the physical therapist assistant licensing board of another state. The evaluation must be on the appropriate coursework tool (CWT) adopted by the Federation of State Boards of Physical Therapy (FSBPT) and reflect the education criteria in place at the time of graduation; and Proof of 1000 clinical practice hours each year in the United States for five (5) out of the last ten (10) years.

(b) Full-time teaching of physical therapist assistant education may count toward 250 of the 1000 required practice hours per year.

(3)An applicant who has failed to pass the National Physical Therapy Examination for Physical Therapist Assistants by or on the fifth attempt, regardless of the jurisdiction through which the examination was taken, is precluded from licensure.

#### 64B17-4.006 Examination Security and Sanctions for Subversions.

(1)The Board incorporates Department Rule 64B-1.004, F.A.C., relating to the security of examinations.

(2)An applicant, licensee, or examinee who is found by the Board, prior to, during, or after

the administration of an examination, to have engaged or to have attempted to engage in conduct that subverts or undermines the integrity of the examination process shall be subject to penalties up to and including disqualification from taking the examination and from licensure as a physical therapist assistant, and up to receiving a failing grade on the examination, if applicable, pursuant to Rule 64B17-7.001, F.A.C.

**MOTION:** After discussion Dr. Tasso voted to repeal Chapter 4 Rules. The motion was seconded by Dr. Donald and carried 5/0.

**MOTION**: Dr. Petraglia made a motion to find the proposed revisions will not be likely to directly or indirectly increase regulatory costs to any entity (including government) in excess of \$200,000 in the aggregate in Florida within 1 year after the implementation of the rule. The Motion was seconded by Dr. Tasso and carried 5/0.

At this time Ms. Norr suggested the Repeal of Rule 64B17-3.003 as this rule was added and incorporated into Rule 3.001.

#### 64B17-3.003 Licensure by Endorsement.

An applicant filing DOH Form #DH-MQA 1142 Application for Licensure, revised 08/14, which is hereby incorporated by reference and is available through http://www.flrules.org/Gateway/reference.asp?No=Ref-04795 or

www.floridasphysicaltherapy.gov/resources, and demonstrating that he or she meets the requirements of Rule 64B17-3.001, F.A.C., may be licensed to practice physical therapy by endorsement by presenting evidence satisfactory to the Board that the applicant has active licensure in another jurisdiction and has passed an examination before a similar, lawful, authorized examining board in physical therapy in such other jurisdiction if their standards for licensure are as high as those maintained in Florida. The standard for determining whether the standards of another jurisdiction are as high as the standards in Florida shall be whether the written examination taken for licensure in such other jurisdiction by applicants meeting Florida's minimum educational qualifications was through the national physical therapy examination provider certified by the Department.

An applicant who has been educated in a foreign country may demonstrate minimum educational qualifications by providing the following:

A certified copy of the credential evaluation used by the physical therapy licensing board of another state. The evaluation must be on the appropriate coursework tool (CWT) adopted by the Federation of State Boards of Physical Therapy (FSBPT) and reflect the education criteria in place at the time of graduation, and;

Proof of 1000 clinical practice hours each year in the United States for five (5) out of the last ten (10) years;

Full-time teaching of physical therapy education may count toward 250 of the 1000 required practice hours per year.

Proof of clinical practice hours in the United States shall consist of submission of a written statement evidencing the number of clinical hours the applicant practiced in each of the five (5) years.

An applicant who has failed to pass the National Physical Therapy Examination for Physical Therapists by or on the fifth attempt, regardless of the jurisdiction through which the examination was taken, is precluded from licensure.

Ms. Gilani summarized the case for the Board. Respondent was charged with the following violation: Section 486.125 (1)(k), Florida Statutes (2015) and 456.072 (1)(x), Florida Statutes (2015). By Failure to report to the Board, in writing within 30 days after the licensee has been convicted or found guilty of, or entered a plea of nolo contendere to, regardless of adjudication, a crime in any jurisdiction constitutes grounds for discipline.

The case was presented as a Settlement Agreement that would impose the following:

- Fine of \$1,000.00 to be paid in 1(one) year from the filing of the Final Order
- Cost of \$659.98 to be paid in 1(one) year from the filing of the Final Order
- Laws and Rules Examination

**MOTION:** Dr. Pabian made a motion to reject the Settlement Agreement and counteroffer with the following:

- Fine of \$1,000.00 to be paid in 1(one) year from the filing of the Final Order
- Cost of \$659.98 to be paid in 1(one) year from the filing of the Final Order
- Completion of the Florida Laws and Rules Exam. Respondent must register within 90 (ninety) days of the filing of the Final Order and successfully pass the exam within 6 (six) months of the filing of the Final Order.
- Two (2) years' probation.
- One (1) month suspension of practice.
- Respondent is required to appear before the Board before practicing in Florida.

The motion was seconded by Dr. Petraglia and carried 4/0.

## REQUEST FOR CONSIDERATION OF EXEMPTION FOR DISQUALIFICATION FROM EMPLOYMENT

#### 16. Esther Curvelo, PT 9931

Ms. Curvelo was present and sworn in by the court reporter.

Certified interpreter, Aldo Goerrero was present and sworn in by the court reporter.

On May 6, 2016 Ms. Curvelo came before the board for a request for exemption from disqualification from employment. After discussion her request was denied due to it not being more than three years after Ms. Curvelo has been released from confinement, supervision or other nonmonetary condition imposed by the court for a disqualifying felony as set forth in 435.07(1)(a)(1), Florida Statutes.

Respondent was charged with the following violation: Section 486.125 (1)(e), Florida Statutes (2012); Rule 64B17-6.001 (5)(d), Florida Administrative Code (2012);486.125 (1)(i), Florida Statutes (2012); by failing to maintain acceptable standards of physical therapy as set forth by the Board in rules adopted pursuant to this chapter constitutes grounds for discipline and by making or filing a report or record which the licensee knows to be false.

The case was presented as a Settlement Agreement that would impose the following:

- Reprimand
- \$5,000 fine to be paid within 2 (two) years of the filing of the Final Order.
- Reimbursement of Costs (\$5,000), to be paid within 2 (two) years of the filing of the Final Order.
- Continuing Education- Board has discretion to determine the number of course hours required for each CE
  - 1 Board-approved course in proper delegation and/or use of unlicensed personnel.
  - 1 Board-approved course in recordkeeping.
  - 1 Board- approved course in ethics.

**MOTION:** Dr. Pabian made a motion to reject the Settlement Agreement and counteroffer with the following:

- Reprimand
- \$5,000 fine to be paid within 2 (two) years of the filing of the Final Order.
- Reimbursement of Costs (\$5,000), to be paid within 2 (two) years of the filing of the Final Order.
- 1 (one) Board-approved course in proper delegation and/or use of unlicensed personnel. The course shall be submitted to Dr. Pabian for approval.
- 1 (one) Board-approved course in recordkeeping. The course shall be submitted to Dr. Pabian for approval.

 Completion of the Florida Laws and Rules Exam. Respondent must register within 90 (ninety) days of the filing of the Final Order and successfully pass the exam within 6 (six) months of the filing of the Final Order.

The motion was seconded by Dr. Petraglia and carried 3/0.

Mr. Pereda accepted the amended Settlement Agreement.
