ADMINISTRATIVE PROCEEDINGS

RULE DISCUSSION AND/OR DEVELOPMENT

1. 64B17-3.001, F.A.C., Licensure
 - Initial Application

64B17-3.001 Licensure.

(1) Application. Every person who applies for licensure as a physical therapist or physical therapist assistant shall file DOH Form #DH-MQA 1142, Application for Licensure, revised ~~10/16~~ 5/19, which is hereby incorporated by reference and is available through <http://www.flrules.org/Gateway/reference.asp?No=Ref-07860>, or www.floridaphysicaltherapy.gov/resources.

(2) Qualifications for Licensure. All applicants for licensure as a physical therapist or physical therapist assistant must demonstrate the following:

- (a) Is eighteen years old;
- (b) Possesses good moral character; and,
- (c) Education:

1. For physical therapists, have received a degree as a physical therapist from a physical therapist educational program accredited by the Commission on Accreditation in Physical Therapy Education (CAPTE), at the time of graduation, or

2. For physical therapist assistants,

a. Have received a degree as a physical therapist assistant from a physical therapist assistant educational program accredited by the Commission on Accreditation in Physical Therapy (CAPTE), at the time of graduation, or

b. Have been enrolled between July 1, 2014, and July 1, 2016, in a physical therapist assistant school in this state which was accredited at the time of enrollment and have been graduated or be eligible to graduate from such school no later than July 1, 2018,

3. For physical therapists and physical therapist assistants who have received a diploma from a program in physical therapy in a foreign country, have received a determination that their credentials are equivalent to the education and preparation required for licensure as a physical therapist or physical therapist assistant in the United States. Educational credentials equivalent to those required for the education and preparation of physical therapists or physical therapist assistants in this country shall be determined by an agency as provided in Rule 64B17-3.007, F.A.C.

(3) Additional provision for applications for licensure without examination (by endorsement).

(a) For purposes of compliance with Sections 486.031, 486.081, and 486.107, F.S., the standard for determining whether the standards of another jurisdiction are as high as the standards in Florida shall be whether the written examination taken for licensure in such other jurisdiction by applicants meeting Florida's minimum educational qualifications was through the national physical therapy examination provider certified by the Department.

(b) Physical therapist applicants who meet the education and examination requirements for licensure without examination shall show proof of an active physical therapist license in another state, the District of Columbia, a territory, or a foreign country. Physical therapist assistant applicants who meet the education and examination requirements for licensure without examination shall show proof of an active physical therapist assistant license in another state, the District of Columbia, or a territory.

(c) An applicant for licensure without examination who has been educated in a foreign country shall demonstrate minimum educational qualifications, as used in paragraph (3)(a), by:

1. Obtaining a determination of educational credentials equivalency as provided by Rule 64B17-3.007, F.A.C., or

2. Providing the following:

a. A certified copy of the credential evaluation used by the physical therapy licensing board of another state. The evaluation must be on the appropriate coursework tool (CWT) adopted by the Federation of State Boards of Physical Therapy (FSBPT) and reflect the education criteria in place at the time of graduation; and,

b. Proof of 1,000 clinical practice hours each year in the United States for five (5) out of the last ten (10) years.

(I) Full-time teaching of physical therapy education may count toward 250 of the 1,000 required practice hours per year.

(II) Proof of clinical practice hours in the United States shall consist of submission of a written statement evidencing the number of clinical hours the applicant practiced in each of the five (5) years.

(4) An applicant for licensure as a physical therapist who has failed to pass the National Physical Therapy Examination for Physical Therapists or an applicant for licensure as a physical therapist assistant who has failed to pass the National Physical

Therapy Examination for Physical Therapist Assistants by or on the fifth attempt, regardless of the jurisdiction through which the examination was taken, is precluded from licensure.

The Board wishes to discuss the questions with the Federation of State Boards of Physical Therapy (FSBPT) and inquire regarding the verbiage of the questions recommended to state Boards.

Upon successful completion of the National Physical Therapy Exam and/or the Florida Laws and Rules Exam, shall be licensed. The motion was seconded by Mr. Chenoweth and carried 3/0.

- Physical Therapist Assistant Applicants

MOTION: Dr. Tasso made a motion to ratify the list of physical therapists assistants for licensure by examination/endorsement (Exhibit B), 167 in number starting with PTA 29081 and ending with PTA 29298. Upon successful completion of the National Physical Therapy Exam and/or the Florida Laws and Rules Exam, shall be licensed. The motion was seconded by Mr. Chenoweth and carried 3/0.

7. Proof of Education: Transcripts Vs. Letter of Completion

To expedite licensure, board offices were tasked to review processes and take steps to reduce deficiencies. Transcripts are the most common deficiency in physical therapy. Currently, a license is not issued until transcripts are received; however, due to the National Physical Therapy Exam (NPTE) testing deadlines with the Federation of State Boards of Physical Therapy (FSBPT) a letter of completion (LOC) is accepted to allow an applicant to sit for the exam.

The Board was asked to allow a LOC rather than a transcript to verify the required education. This would be an efficient process for new graduates and staff while continuing to ensure those approved for testing have met the education requirements.

The Board requested Counsel to review the Florida Statutes and determine rule making authority. This discussion as well as Rule 64B17-3.001, Licensure, will be added to the August agenda for further review.

MOTION FOR BOARD'S FINAL ORDER BY SETTLEMENT AGREEMENT

Ms. Shideler summarized the case for the Board. Respondent was charged with the following violation: **Count I:** 486.125 (1)(k), Florida Statutes (2017) for violating any provision of this chapter or chapter 456 or any rules thereunto. **Count II:** 456.072(1)(x), Florida Statutes (2017) for failure report to the Board guilty plea within 30 days.

PETITION FOR WAIVER OF RULE & CONSIDERATION OF APPLICATION FOR LICENSURE BY ENDORSEMENT AS A PHYSICAL THERAPIST

10. Monica Rita Cotik-Bilsky, Foreign Trained Physical Therapist by Endorsement

Ms. Cotik-Bilsky was present and sworn in by the court reporter.

Ms. Cotik-Bilsky petitioned the Board for variance and waiver of Rule 64B17-3.001 (2)(a) and (3)(c), F.A.C.

Ms. Cotik-Bilsky requested a waiver from the education requirement(s) as she was unable to obtain the required certified copy of her IERF credential evaluation used by another physical therapy licensing board, as it is no longer available.

The board received an evaluation completed on an education checklist addressed to Mr. Daniel Wheeler, Physical Therapy Examining Committee in California. Ms. Cotik-Bilsky is requested consideration of this checklist as evidence of qualifications to meet Florida's requirements.

MOTION: After discussion, Dr. Tasso made a motion to grant Ms. Cotik-Bilsky's petition for waiver of rule 64B17-3.001 (2)(a) and (3)(c), F.A.C. as Ms. Cotik-Bilsky demonstrated equivalency by other means via the IERF report from 1998 and by demonstrating financial hardship due to failure to retrieve the syllabi from her foreign county. The motion was seconded Mr. Chenoweth and carried 3/0.

MOTION: After discussion, Dr. Tasso made a motion to approve Ms. Cotik-Bilsky's application for licensure and to certify her to sit for the Florida Laws and Rules Exam, and upon a passing score on the exams shall be licensed due to educational evidence that she has met the educational requirements. The motion was seconded by Mr. Chenoweth and carried 3/0.

11. Bela Contractor, Foreign Trained Physical Therapist by Endorsement

Ms. Contractor petitioned the Board for variance and waiver of Rule 64B17-3.001, F.A.C.

Ms. Contractor is requested a waiver from the education requirement(s) as she is unable to obtain the required certified copy of her ICD credential evaluation used by another physical therapy licensing board, as it is no longer available.

Board Staff received a revised ICD evaluation on February 15, 2019, confirming she received credit for Social Sciences; however, Ms. Contractor does not meet the educational requirements as she lacks required course content in professional education.

MOTION: After discussion, Dr. Tasso made a motion to deny Ms. Contractor's petition for waiver of rule 64B17-3.001, F.A.C. The motion was seconded Dr. Pabian and carried 3/0.

12. Maria Fumero, Foreign Trained Physical Therapist by Endorsement

Ms. Fumero was present and sworn in by the court reporter.

Ms. Fumero petitioned the Board for variance and waiver of Rule 64B17-3.007(g), F.A.C.

Ms. Fumero is unable to retrieve official education documents from her county due to political reasons. Ms. Fumero is requesting the Board allow her the ability to use her personal copy of her educational documents to be submitted to the credentialing agency in order to have a credential evaluation completed for Florida.

MOTION: After discussion, Dr. Tasso made a motion to grant Ms. Fumero's petition for waiver of rule 64B17-3.007(g), F.A.C and allow IERF to use the current documentation they have to complete her evaluation. The motion was seconded Mr. Chenoweth and carried 3/0.
