DISCIPLINARY PROCEEDINGS

MOTION FOR BOARD'S FINAL ORDER BY HEARING NOT INVOLVING DISPUTED ISSUES OF MATERIAL FACT AND FOR FINAL ORDER

- 1. Robert A. Henry, PTA (PCP: Donald, Tasso, Candela)**

Respondent was not present nor represented by counsel.

Dr. Donald was recused due to participation in the probable cause panel.

Ms. Nolen summarized the case for the Board. Respondent was charged with the following violation: 456.072 (1)(v) through a violation of 456.063(1). 456.072 Florida Statutes (2021) subjects a licensee to discipline for engaging or attempting to engage in sexual misconduct as defined and prohibited in 456.603(1). 456.063(1) , Florida Statutes (2021), prohibits sexual misconduct in the practice of a health care profession and specifically provides that: Sexual misconduct in the practice of a health care profession means violation of the professional relationship through which the health care practitioner uses such relationship to engage or attempt to engage the patient, client or an immediate family member, guardian, or representative of the patient or client in, or to induce or attempt to induce such person to engage in, verbal or physical sexual activity outside the scope of professional practice of such health care profession. Sexual misconduct in the practice of a health care profession is prohibited.

MOTION: Mr. Chenoweth made a motion to accept the investigative report into evidence. The motion was seconded by Dr. Koenig and carried 3/0.

MOTION: Mr. Chenoweth made a motion to find that the Respondent was properly served and waived the right to a formal hearing. The motion was seconded by Dr. Koenig and carried 3/0.

MOTION: Mr. Chenoweth made a motion to adopt the findings of fact as set forth in the Administrative Complaint. The motion was seconded by Dr. Koenig and carried 3/0.

MOTION: Mr. Chenoweth made a motion to adopt the conclusions of law as set forth in the Administrative Complaint and find that this constitutes a violation of the Chapters 486 and 456, Florida Statutes. The motion was seconded by Dr. Koenig and carried 3/0.

MOTION: After discussion, Mr. Chenoweth made a motion to impose the following penalties:

- 5,000 fine within in 1 year.
- Revocation

The motion was seconded by Dr. Koenig and carried 3/0.

MOTION: Mr. Chenoweth made a motion to assess and accept costs of \$1,362.13 made payable within one (1) year. The motion was seconded by Dr. Kleponis and carried 3/0.

MOTION FOR SETTLEMENT AGREEMENT

2. Tonya L. Willroth, PTA (PCP: Pabian, Watson, Bumgarner)

Respondent was present and represented by counsel, Thomas Buchanan, Esq.

Ms. Nolen summarized the case for the Board. Respondent was charged with the following violation: **Count I:** 486.125 (1)(b), Florida Statutes (2017) subjects a physical therapist assistant to discipline for committing fraud in the practice of physical therapy or deceit in obtaining a license as a physical therapist assistant. **Count II:** 486.125 (1)(i),

Florida Statutes, subjects a physical therapist assistant to discipline for making or filing a report or record which the licensee knows to be false. Such reports or records shall include only those which are signed in the capacity of a physical therapist.

MOTION: After discussion, Dr. Donald made a motion to accept the settlement agreement and impose the following penalties:

- \$10,000 fine payable in five (5) years (with \$2,000 due each year, remainder in last year)
- \$1,000 in costs payable within (5) five years (with \$200 due each year)
- 10 (ten) hours of continuing education in record keeping and ethics within 90 (ninety) days.
- Suspension of Respondent's license for three (3) months
- 1-Year probation with supervision- 25% patient chart review, ride along, accompany with direct patient contact. Probation will not start until the Board approves a monitor. Minimum of 8 in person visits. Can't be the same patient, once every quarter.

The motion was seconded by Dr. Koenig and carried 4/0.

MOTION: After discussion, Dr. Kleponis made a motion to vacate the prior discipline order. The motion was seconded Dr. Koenig and carried 3/0.

MOTION: After discussion, Dr. Donald made a motion to impose the following penalty:

- 2-year suspension
- 2-year probation with supervision- 25% patient chart review, ride along, accompany with direct patient contact. Probation will not start until the Board approves a monitor. Minimum of 8 in person visits. Can't be the same patient, once every quarter.
- 10-hour documentation, ethics documentation approved by the Board and due by the end of the probationary period.
- Restriction of license to patients who can only give informed consent for the life of his license.
- 10,000 fines by the end of the probation period

The motion was seconded Dr. Kleponis and carried 3/0.

MOTION: Dr. Donald made a motion to assess and accept costs of \$1,950.24 made payable by the completion of the probationary period. The motion was seconded by Dr. Koenig and carried 3/0.

4. PT Compact Information

The Federation of State Boards of Physical Therapy (FSBPT) and the Florida Physical Therapy Association (FPTA) requested to present information related to the PT Compact and a 2023 legislative proposal.

Individual who is licensed in a member state, provide physical therapy in another member state without applying for a full license.

State has the ability to have the compact privilege states Laws and Rules exam for the state attempting to enter into a compact agreement.

Tad Fischer, FPTA president spoke to the Board regarding the 2023 legislative proposal. Mr. Fischer explained to the Board the FPTA's position during the process while preparing the bill proposal and the relationship between the FPTA and the FSBPT.

PERSONAL APPEARANCE PURSUANT TO §456.013(3)(c), F.S.

5. Heidi Gonzales-Negron, PT by Endorsement

Ms. Gonzales-Negron was not present.

While Board staff received a credential evaluation, it does not meet the requirements of our rule. Staff reached out to the applicant regarding the rule language and requirements for a Florida license.

The applicant has requested the Board to review her file "as is" on April 28, 2022. Ms. Gonzalez-Negron did not attend the May 20, 2022 meeting. She was sent an Order

Requiring her Appearance at the August meeting on June 14, 2022.

MOTION: After discussion, Mr. Chenoweth made a motion to deny Ms. Gonzales-Negron's application by Endorsement for failure to appear and not having the appropriate credential evaluation, the Final Order will allow her 21 days to withdraw her application. The motion was seconded by Dr. Kleponis and carried 4/0.

6. Michael J. Healy, PTA by Endorsement

Mr. Healy was present.

The Indiana Board accepted Mr. Healy's request to remove his license from probation on January 7, 2005, through compliance of all terms of probation.

MOTION: After discussion, Dr. Koenig made a motion to approve Mr. Healy's application for licensure and to certify him to sit for the Florida Laws and Rules Exam and upon a passing score on the exam he shall be licensed. The motion was seconded by Dr. Donald and carried 4/0.

7. Fernando Perez Rubio, PT by Examination

Mr. Perez Rubio was present.

Mr. Perez Rubio petitioned the Board for the variance of the waiver on November 29, 2021, which was heard on February 11, 2022, regarding educational credentials.

The Board approved his petition and conditionally approved his application, Mr. Perez was to submit a new evaluation within a year of this order. A board appearance would be required if the credential evaluation was deemed not equivalent.

On August 5, 2022, we received a credential evaluation that deemed Mr. Perez Rubio's education not equivalent.

Mr. Perez Rubio requested to withdraw his application. Mr. Chenoweth approved the withdraw. The motion was seconded by Dr. Kleponis and carried 4/0.

8. Armando Calvo, PTA by Examination

Mr. Calvo was present.

Mr. Calvo previously applied for licensure in 2014 and appeared before the Board at the August 5, 2016, meeting.

After discussion, the Board allowed him to withdraw his application.

Mr. Calvo has now re-applied for licensure in the State of Florida.

MOTION: After discussion, Dr. Koenig made a motion to approve Mr. Calvo's application for licensure and to certify him to sit for the National Physical Therapy Examination and the Florida Laws and Rules Exam, upon passing scores for both exams he shall be licensed. The motion was seconded by Dr. Donald and carried 4/0.

Mr. Julio Diaz requests clarification of documentation and evidence considered necessary and mandatory for a foreign Physical Therapist to be eligible for licensing in Florida through a recognition process without examination as described in Florida Statute, Title XXXII Chapter 486, specifically, subsection 486.081.

MOTION: After discussion, Dr. Donald made a motion to deny Mr. Diaz's request for a declaratory statement does not meet standard, rule is clear for licensure by endorsement. The motion was seconded by Dr. Kleponis and carried 4/0.

NEW BUSINESS

22. Discussion: Rule 64B17-3.002, F.A.C., Additional Requirements After Third Failure

At the May 20, 2022, meeting, the Board requested a discussion of rule 64B17-3.002, F.A.C., regarding remedial courses for applicants who failed to pass the NPTE exam on the third attempt.

When an applicant does not pass the NPTE exam on their third attempt, board staff sends a letter with an attachment that lists potential remedial courses. The letter asks that they complete a retake application, pay the \$100.00 fee, and provide a remedial certificate of completion before being approved for their fourth NPTE attempt.

Third time failure data by examination date:

07/05-06/2022 - PTA exam - 86 failed scores total - 9 third time failures.

04/06-07/2022 - PTA Exam - 79 failed scores total - 18 third time failures.

01/05-06/2022 - PTA Exam - 67 failed scores total - 22 third time failures.

07/27-28/2022- PT exam - 61 failed scores total - 6 third time failures.

04/27-28/2022 - PT exam - 56 failed scores total - 15 third time failures.

01/26-27/2022 - PT exam - 65 failed scores total - 17 third time failures.

486.104 Physical therapist assistant; examination of applicant.—The examination of an applicant for licensing as a physical therapist assistant shall be in accordance with rules adopted by the board, to test the applicant's qualifications and shall include the taking of a test by the applicant. If an applicant fails to pass the examination in three attempts, the applicant shall not be eligible for reexamination unless she or he completes additional educational or training requirements prescribed by the board. An applicant who has completed the additional educational or training requirements prescribed by the board may take the examination on two more occasions. If the applicant has failed to pass the examination after five attempts, she or he is no longer eligible to take the examination.

486.051 Physical therapist; examination of applicant.—The examinations of an applicant for licensing as a physical therapist shall be in accordance with rules adopted by the board, to test the applicant's qualifications and shall include the taking of a test by the applicant. If an applicant fails to pass the examination in three attempts, the applicant shall not be eligible for reexamination unless she or he completes additional educational or training requirements prescribed by the board. An applicant who has completed the additional educational or training requirements prescribed by the board may take the examination on two more occasions. If the applicant has failed to pass the examination after five attempts, she or he is no longer eligible to take the examination.

64B17-3.002 Licensure Examination and Passing Score; Laws and Rules Examination; Additional Requirements After Third Failure.

(4) Examination retakes.

(a) In order to retake either the NPTE or the Florida Laws and Rules Examination, an applicant must reapply, using DOH Form #DH-MQA 1143, Re-Examination Application for physical Therapist or Physical Therapist Assistant, Revised 12/2020, incorporated by reference, which is available through <http://www.flrules.org/Gateway/reference.asp?No=Ref-12673>, or www.floridasphysicaltherapy.gov/resources.

(b) If an applicant wishes to take the NPTE examination for the fourth time, the applicant must submit to the Board for approval satisfactory evidence of having successfully completed the

following since the last taking of the examination: successful completion of a course of study or internship designed to prepare the applicant for the physical therapy examination. An applicant who has completed these additional requirements may take the examination on two more occasions.

Dr. Kleponis to write language regarding the content of the remedial information and the content.
