MOTION FOR BOARD'S FINAL ORDER BY HEARING NOT INVOLVING DISPUTED ISSUES OF MATERIAL FACT

- Hugh Martin Robinson, PTA (PCP: Koenig, Bumgarner & Tasso)**

Respondent was not present nor represented by counsel.

Dr. Koenig was recused due to participation in the probable cause panel.

Ms. Nolen summarized the case for the Board. Respondent was charged with the following violation: 486.125 (1)(g) Florida Statutes (2020-2021), subjects a licensee to discipline for having a license revoked or suspended; having had other disciplinary action taken against her or him; or having had her or his application for a license refused, revoked, or suspended by the licensing authority of another state, territory, or country.

MOTION: Mr. Chenoweth made a motion to accept the investigative report into evidence. The motion was seconded by Dr. Donald and carried 3/0.

MOTION: Mr. Chenoweth made a motion to find that the Respondent was properly served and waived the right to a formal hearing. The motion was seconded by Dr. Donald and carried 3/0.

Respondent was charged with the following violation: 456.072 (1)(c) Florida Statutes (2021) subjects a physical therapist to discipline for being convicted or found guilty of or entering a plea of guilty or nolo contendere to, regardless of adjudication, a crime in any jurisdiction which relates to the practice of, or the ability to practice, a licensee's profession.

MOTION: Mr. Chenoweth made a motion to accept the investigative report into evidence. The motion was seconded by Dr. Koenig and carried 4/0.

MOTION: Mr. Chenoweth made a motion to find that the Respondent was properly served and waived the right to a formal hearing. The motion was seconded by Dr. Koenig and carried 4/0.

MOTION: Mr. Chenoweth made a motion to adopt the findings of fact as set forth in the Administrative Complaint. The motion was seconded by Dr. Koenig and carried 4/0.

MOTION: Mr. Chenoweth made a motion to adopt the conclusions of law as set forth in the Administrative Complaint and find that this constitutes a violation of the Chapters 486 and 456, Florida Statutes. The motion was seconded by Dr. Donald and carried 4/0.

Mr. Dorvilus made a request for a continuance of the case.

MOTION: After discussion, Dr. Donald denied the request for a continuance. The motion was seconded by Dr. Koenig and carried 4/0.

MOTION: After discussion, Dr. Donald made a motion to impose the following penalties:

- Revocation

Mr. Chenoweth made a motion to amend the penalties and waive the fine of \$5,000. The motion was seconded by Dr. Kleponis and carried 4/0.

MOTION: Mr. Chenoweth made a motion to assess and accept costs of \$6,475.47, to be paid within two (2) years with \$3,500 due in the first year and the remainder due the second year. The motion was seconded by Dr. Koenig and carried 4/0.

MOTION FOR SETTLEMENT AGREEMENT

3. Shannon Keathley, PT (PCP: Tasso, Candela & Watson)

Respondent was present and represented by counsel, Rickey Strong, Esq.

Ms. Nolen summarized the case for the Board. Respondent was charged with the following violation: 486.125 (1)(i), Florida Statutes (2016), subjects a licensee to discipline for making or filing a report or record which the licensee knows to be false. Such reports or records shall include only those which are signed in the capacity of a physical therapist.

MOTION: After discussion, Dr. Kleponis made a motion to accept the settlement agreement and impose the following penalties:

- Administrative fine of \$5,000.00 to be paid within two (2) years of the filing of the final order accepting this agreement, with \$2,500.00 due in the first year and the remainder in the second year.
- Costs within two (2) years of the filing of the final order accepting this agreement, with \$1,00.00 due in the first year and the remainder in the second year. Not to exceed \$2,000.00.
- Completion of ten (10) hours of Board approved continuing education in the area of ethics and laws and rules within six (6) months of the filing of the final order accepting this agreement.

- One (1) year probation from the date of the filing of the Final Order accepting this agreement. Practicing under the indirect monitoring of a physical therapist approved by the Board Chair. Probationary term begins only after; the Board Chair has approved respondents' probation monitor and the monitor has begun the first review of respondents practice records.

MOTION: The motion was seconded by Dr. Donald and carried 4/0.

MOTION FOR DETERMINATION OF WAIVER BY HEARING NOT INVOLVING DISPUTED ISSUES OF MATERIAL FACT

4. Michael D. Lamb, PTA (PCP: Donald, Candela & Tasso)

Respondent was not present nor represented by counsel.

Dr. Donald was recused due to participation in the probable cause panel.

Ms. Nolen summarized the case for the Board. Respondent was charged with following violation: 486.125 (1)(k) through a violation of rule 64B17-6.001(4)(h). 486.125 (1)(k) , Florida Statutes (2021), subjects a licensed physical therapist assistant to discipline for violating any provision of this chapter or chapter 456, or any rules adopted pursuant thereto. 64B17-6.001(4)(h), Florida Administrative Code, states that a physical therapist assistant shall complete accurate written medical records documenting the course of treatment for each patient.

MOTION: Mr. Chenoweth made a motion to accept the investigative report into evidence. The motion was seconded by Dr. Koenig and carried 3/0.

MOTION: Mr. Chenoweth made a motion to find that the Respondent was properly served and waived the right to a formal hearing. The motion was seconded by Dr. Koenig and carried 3/0.

MOTION: Mr. Chenoweth made a motion to adopt the findings of fact as set forth in the Administrative Complaint. The motion was seconded by Dr. Koenig and carried 3/0.

MOTION: Mr. Chenoweth made a motion to adopt the conclusions of law as set forth in the Administrative Complaint and find that this constitutes a violation of the Chapters 486 and 456, Florida Statutes. The motion was seconded by Dr. Koenig and carried 3/0.

MOTION: After discussion, Mr. Chenoweth made a motion to impose the following penalties:

- Reprimand
- \$5,000 fine to be paid in 2 years- with \$2,500 to be paid each year.
- 10 hours of continuing education in ethics and laws and rules.
- One (1) year probation from the date of the filing of the Final Order accepting this agreement. Consisting of monitoring with 25% patient record review at least once per quarter.

The motion was seconded by Dr. Koenig and carried 3/0.

MOTION: Mr. Chenoweth made a motion to assess and accept costs of \$2,757.55, with \$2,000 due the first year and the remainder due the second year. The motion was seconded by Dr. Kleponis and carried 3/0.

5. Andres Manuel Torres, PTA (PCP: Koenig, Bumgarner & Tasso)

Respondent was not present nor represented by counsel.

Dr. Koenig was recused due to participation in the probable cause panel.

Ms. Nolen summarized the case for the Board. Respondent was charged with following violations: **Count I:** 456.072 (1)(c), Florida Statutes (2021), subjects a physical therapist to discipline for being convicted or found guilty of, or entering a plea of guilty or nolo contendere to, regardless of adjudication, a crime in any jurisdiction which relates to the practice of, or the ability to practice, a licensee's profession. **Count II:** 456.072(1)(x), Florida Statutes (2021), subjects a physical therapist assistant to discipline for failing to report to the board in writing within 30 days after the licensee has been convicted or found guilty of, or entered a plea of nolo contendere to, regardless of adjudication, a crime in any jurisdiction.

MOTION: Mr. Chenoweth made a motion to accept the investigative report into evidence. The motion was seconded by Dr. Donald and carried 3/0.

MOTION: Mr. Chenoweth made a motion to find that the Respondent was properly served and waived the right to a formal hearing. The motion was seconded by Dr. Donald and carried 3/0.

MOTION: Mr. Chenoweth made a motion to adopt the findings of fact as set forth in the Administrative Complaint. The motion was seconded by Dr. Donald and carried 3/0.

- 8 hours continuing education in laws and rules from the date the order of suspension is lifted.
- Anger management course within 60 days from the date the suspension order is lifted.

The motion was seconded by Dr. Kleponis and carried 3/0.

MOTION: Dr. Kleponis made a motion to assess and accept costs of \$163.97 to be paid within one (1) year. The motion was seconded by Dr. Donald and carried 3/0.

6. Robert Patrick McEntire, PT (PCP: Koenig, Bumgarner & Tasso)

Respondent was not present nor represented by counsel.

Dr. Koenig was recused due to participation in the probable cause panel.

Ms. Nolen summarized the case for the Board. Respondent was charged with following violation: 486.125 (1)(g), Florida Statutes (2020-2021), subjects a licensee to discipline for having a license revoked or suspended; having had other disciplinary action taken against her or him; or having had her or his application for a license refused, revoked, or suspended by the licensing authority of another state, territory, or country.

The Florida Consortium of Clinician Educators (FCCE) would like to investigate a change in the number of CEUs that can be earned, per biennium, for being a Clinical Instructor (CI) for a Physical Therapy (PT) and Physical Therapy Assistant student (PTA).

The current Statue is as follows:

(6) Clinical Instructors shall receive 1 contact hour for every 160 hours of clinical internship limited to a maximum of 6 contact hours per instructor per biennium. Clinical instructors must be credentialed by the American Physical Therapy Association (APTA) to receive clinical continuing education credits.

After investigating 50 states Practice Acts and Statutes regarding Clinical Instructors (CIs) supervising PT/PTA students, we envision the following update to 64B17-9.001 (6)

Clinical Instructors (CIs) shall receive 1 contact hour for every 120 hours of full-time clinical experience limited to a maximum 8 Contact hours per instructor per biennium. Clinical Instructors must be credentialed by the American Physical Therapy Association (APTA) to receive clinical continuing education credits.
